#### **TREASURY**

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 9 and 13 of, and Schedule 5, to the Import Duties Act, 1958, and Section 2(5) of the Finance Act 1965.

viz: The Import Duty Drawbacks (No. 9) Order 1965.

#### This Order:

- (i) provides for the allowance of drawback of import duty on the exportation of
  - (a) imported fresh oranges, exported in the cases in which they were imported;
  - (b) a wider range of specified products of "improved" wood, within the meaning of Chapter 44 of the Customs Tariff 1959, manufactured from imported wooden veneer sheets;
  - (c) certain insulated copper strip or wire manufactured from certain imported artificial resins and imported linseed oil;
  - (d) certain lubricating oil additives and specified organic chemicals manufactured from specified imported acetone cyanohydrin; and
  - (e) certain zinc alloy ingots manufactured from certain imported zinc and exported on or before 3rd December, 1968; and
- (ii) reduces the rate of drawback of import duty on imported tomato purée or paste used in the manufacture for export of foodstuffs, canned or bottled in tomato sauce.

The Order comes into operation on the 1st December, 1965, and has been published as Statutory Instruments 1965, No. 1985.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 3(12) of the Finance (No. 2) Act, 1964, viz.:—The Temporary Charges on Imports (Continuation) Order, 1965.

This Order was approved by the House of Commons on 29th November, 1965.

This Order continues until the end of November, 1966, the temporary charge on imports imposed by Section 3 of the Finance (No. 2) Act, 1964. Subsection (9) of that Section provides for earlier reductions in the rate, or cessation, of the duty; the initial rate of 15 per cent was reduced to 10 per cent by the Temporary Charges on Imports (Reduction) Order, 1965 (SI. 1965/903) made under that subsection.
