## SUPREME COURT, NORTHERN IRELAND

### THE RULES OF THE SUPREME COURT (NORTHERN IRELAND) (No. 2) 1966

Notice is hereby given that on the 17th February, 1966, the Northern Ireland Supreme Court Rules Committee, in exercise of the powers conferred by Section 7 of the Northern Ireland Act, 1962, made the Rules of the Supreme Court (Northern Ireland) (No. 2) 1966, S. R. & O. (N.I.) 1966 No. 35. These rules come into force on the 1st March, 1966.

The rules amend Order LXXXIV and provide that in a criminal cause or matter an application for an order of mandamus, prohibition or certiorari shall be made to a Divisional Court instead of to a single Judge. A new paragraph (7) to rule 33 deals with the right of the Court of Appeal, in a civil cause or matter, to hear and determine an application for an order under rule 33 where the Court has granted leave under rule 14 on an appeal from the refusal of such leave by a Judge.
