Station, Markethill, Co. Armagh, such notice to be received within 21 days of the date of seizure, or, where notice of the seizure is published in the Belfast Gazette, within ten days of such publication, whichever period shall terminate the later.

If no such claim is received as aforesaid the said Order provides that the livestock shall be deemed to be condemned as forfeited.
