A PROCLAMATION

ALTERING CERTAIN DAYS APPOINTED FOR  
BANK HOLIDAYS IN THE YEAR 1967

Whereas it is considered inexpedient that the Monday in Whitsun week and the first Monday in August should be Bank Holidays in the year 1967:

Now, therefore, I, John Maxwell, Baron Erskine of Rerrick, Knight Grand Cross of the Most Excellent Order of the British Empire, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland in exercise of the powers conferred on me by Section 5 of the Bank Holidays Act 1871, Section 3 of the Holidays Extension Act 1875, and of every power Me thereunto enabling, do hereby declare and appoint as follows:

1. In the year 1967 the Monday in Whitsun week shall not be a Bank Holiday and instead the last Monday in May shall be a Bank Holiday.
2. In the year 1967 the first Monday in August shall not be a Bank Holiday, and instead the last Monday in August shall be a Bank Holiday.
3. In this Proclamation the expression "Bank Holiday" shall include a public holiday in the Inland Revenue Offices and a holiday in the Customs and Excise.

Given at Government House, Hillsborough, this thirtieth day of August, one thousand, nine hundred and sixty-six.

DIPLOMATIC PRIVILEGES ACT, 1964
