ANCIENT MONUMENTS

Whereas the Council of the Urban County District of Downpatrick (hereinafter referred to as "the Urban Council") on the 23rd day of September, 1965, submitted a proposal to the Council of the Administrative County of Down (hereinafter referred to as "the County Council") for the alteration of the boundary of the said Urban County District:

And whereas the County Council, in exercise of the powers conferred upon them by section 24 of the Local Government Act (Northern Ireland) 1934(a), and of all other powers thereunto them enabling, at a meeting held on the 16th day of June, 1966, made an Order (as set out in the Schedule and hereinafter referred to as "the Order") giving effect to the said proposal subject to certain modifications:

And whereas the Ministry of Development (hereinafter referred to as "the Ministry") is satisfied that the County Council have complied with the provisions of the said Act and the Urban Districts Boundaries (Procedure) Order 1936(b), as to the giving of notice of the provisions of the Order:

And whereas no appeal has been presented to the Ministry:

And whereas it is enacted in effect by section 24(4) of the said Act that the Order shall be submitted to the Ministry and that the Ministry may confirm the Order without modification or subject to such modifications as the Ministry thinks fit or may disallow the Order:

URBAN COUNTY DISTRICT OF
DOWNPATRICK

The Local Government Acts (N.I.) 1898-1962 and the Urban District Boundaries (Procedure) Order, 1936

ORDER

Of the Council of the Administrative County of Down altering the Boundary of the said Urban County District

Whereas on the 23rd day of September, 1965, application was made by the Urban County District of Downpatrick to the Council of the Administrative County of Down (hereinafter called the County Council) pursuant to the provisions of Section 24 of the Local Government Act (N.I.) 1934, for the alteration of the existing Boundary of the said Urban County District.

And whereas the County Council being satisfied that a prima facie case had been made out, caused a

Local Inquiry to be held on the 15th day of February, 1966, by a Committee consisting of G. McSpadden, Esq., O.B.E., LL.B., F. C. Tughan, Esq., and Captain D. J. R. Ker, M.A., D.L. (hereinafter called the Committee).

And whereas the Committee duly reported its findings to the Finance, Law and Parliamentary Committee of the County Council on the 22nd day of April, 1966.

And whereas the said Finance, Law and Parliamentary Committee recommended to the County Council that effect be given to the application of the Urban County District of Downpatrick subject to certain modifications.

And whereas at the Meeting of the County Council held on the 5th day of May, 1966, the said County Council accepted the recommendations of the Finance, Law and Parliamentary Committee of the said County Council.

Now therefore, we the Council of the Administrative County of Down, in pursuance of the powers conferred upon us by the said Section 24 of the Local Government Act (N.I.) 1934, and of all other powers us thereunto enabling, do hereby order as follows:

- (1) That the Boundary of the said Urban County District of Downpatrick be altered by including within the said Urban County District of Downpatrick the area described in the Schedule hereto and more particularly delineated on the Map annexed hereto, whereon the additional area is shown between the red line and the green line.
- (2) That every person holding office on 1st April, 1966, as County or District Councillor for any area affected by this Order and every County or District Councillor elected for any such area before the 1st day of April, 1966, shall be deemed to have been elected for the area as altered by this Order, and the County or District Council of which he is a member shall be deemed to have been elected for the County District as altered by this Order.
- (3) That the Bye-Laws at present in force in the said Urban County District shall apply to the area added to the said Urban County District by this Order.
- (4) That the local and adopted Acts and local Orders in force in the said Urban County District shall apply to the area added to the said Urban County District by this Order.
- (5) That notwithstanding the alteration of the Boundary of the said Urban County District by this Order the said County Council shall have power to recover arrears of rates in the area affected.
- (6) That the financial adjustments consequent upon the making of this Order shall be the subject of an Agreement to be entered into by the parties concerned, such Agreement to be approved by the Ministry of Development for Northern Ireland, and in the absence of agreement between the parties shall be determined by the said Ministry.
- (7) Save as hereinafter expressly provided this Order shall come into operation on the 1st day of April, 1967.
Provided that for the purposes of:
 - (a) the alteration or re-arrangement of any register of electors;
 - (b) the alteration of valuation lists to take part on the appointed day or the preparation or service of any precept to be made in respect of the financial year commencing on the appointed day; and
 - (c) the preparation or approval of any general rate or special rate to be made in respect of a period commencing on the appointed day;
 this Order shall operate from the confirmation thereof by the Ministry of Development.
- (8) This Order may be cited as the Downpatrick Urban District (Alteration) Order, 1966.

**URBAN DISTRICT OF DOWNPATRICK
DESCRIPTION OF BOUNDARY ALTERATION**

Commencing from point A where the centre of carriageway of the Downpatrick-Strangford Road (Route A25) meets the existing Urban District Boundary, thence along the centre of carriageway of the Downpatrick-Strangford Road (Route A25) in a north easterly direction for a distance of about 3,655 feet to the point B.

From the point B along the existing townland boundary between the townlands of Demesne of Down and Quoile to the point C.

From the point C in an easterly direction along the centre of a hedge for a distance of about 295 feet, and along the centre of a bank for a distance of about 170 feet, thence in north easterly, easterly and south easterly directions along the centre of a fence for a distance of about 60 feet, thence in an easterly direction along the centre of a hedge for a distance of about 265 feet, along the centre of a wall for a distance of about 10 feet, along an undefined boundary for a distance of about 40 feet, and along the centre of a wall for a distance of about 100 feet, thence in a north easterly direction along the centre of a hedge for a distance of about 220 feet, thence in an easterly direction along the north face of a wall for a distance of about 80 feet, and along the centre of a wall for a distance of about 20 feet, thence in a south easterly direction along the centre of a fence for a distance of about 25 feet, thence in a generally easterly direction along the centre of a bank for a distance of about 430 feet, and along the centre of a wall for a distance of about 270 feet to the point D.

From the point D along the existing townland boundary between the townlands of Quoile and Saul to the point E.

From the point E in a southerly direction along the centre of a fence for a distance of about 190 feet, and along the centre of a wall for a distance of about 110 feet, thence in an easterly direction along the centre of a fence for a distance of about 275 feet, thence in a south easterly direction along the centre of a hedge for a distance of about 290 feet, and along the centre of a wall for a distance of about 315 feet to the centre of hedge bounding the North side of the Downpatrick-Saul Road (Route C281), thence in a south westerly direction along the centre of a hedge for a distance of about 495 feet, thence in a south easterly direction along an undefined boundary for a distance of about 50 feet, along the centre of a lane for a distance of about 465 feet, and along the centre of a wall for a distance of about 1,340 feet, thence in a north easterly direction along the centre of a wall for a distance of about 255 feet, thence in a south easterly direction along the centre of a wall for a distance of about 530 feet to the point F.

From the point F along the existing townland boundary between the townlands of Saul and Struell to the point G.

From the point G along the existing townland boundary between the townlands of Killavees and Struell to the point H.

From the point H along the existing townland boundary between the townlands of Russell's Quarter and Struell to the point J.

From the point J along the existing townland boundary between the townlands of Russell's Quarter and Clogher to the point K.

From the point K along the existing townland boundary between the townlands of Russell's Quarter and Saul Quarter to the point L.

From the point L along the existing townland boundary between the townlands of Demesne of Down and Saul Quarter to the point M.

From the point M along the existing townland boundary between the townlands of Demesne of Down and Ballymote Upper to the point N.

From the point N along the existing townland boundary between the townlands of Ballyvange and Ballymote Upper to the Point O.

From the point O in a north westerly direction along an undefined boundary for a distance of about

20 feet, thence in a south westerly direction along the centre of a fence for a distance of about 165 feet, and along the centre of a hedge for a distance of about 360 feet, thence in a south easterly direction along the east face of a wall for a distance of about 6 feet, thence in a south westerly direction along the south east face of a wall for a distance of about 145 feet, thence in a westerly direction along the south face of a wall for a distance of about 1,410 feet, and along an undefined boundary for a distance of about 25 feet to the point P.

From the point P along the existing townland boundary between the townlands of Ballyvange and Quarter Cormick to the point Q.

From the point Q in a south westerly direction along the centre of carriageway of the No. 318 Down/Tyrella Road for a distance of about 80 feet, thence in a north westerly direction along an undefined boundary for a distance of about 15 feet, along the centre of the west boundary fence of the disused railway for a distance of about 790 feet, along an undefined boundary for a distance of about 135 feet, and along the centre of the west boundary fence of the disused railway for a distance of about 2,040 feet to the point R.

From the point R along the existing townland boundary between the townlands of Ballydugan and Ringreagh to the point S on the centre line of the north boundary hedge of the Downpatrick/Clough Road (Route A25).

From the point S in a north easterly direction along the centre of a hedge for a distance of about 50 feet, thence in a northern direction along the centre of a hedge for a distance of about 25 feet, thence in a generally north easterly direction along the centre of a fence for a distance of about 470 feet, and along the centre of the west boundary fence of the disused railway for a distance of about 815 feet, thence in a north easterly direction along an undefined boundary for a distance of about 350 feet to the point T on the junction of the north boundary fence of the disused railway with the existing townland boundary between the townlands of Demesne of Down and Ringreagh.

From the point T along the existing townland boundary between the townlands of Demesne of Down and Ringreagh to the point U.

From the point U along the existing townland boundary between the townlands of Demesne of Down and Hollymount to the point V.

From the point V along the existing townland boundary between the townlands of Demesne of Down and Inch to the point W.

From the point W in a south easterly direction along the centre of carriageway of the Downpatrick/Crossgar Road (Route A7) for a distance of about 1,500 feet to the point X.

From the point X along the existing Urban District Boundary to the point A.

The alteration includes the townlands of Killavees, Russell's Quarter, Audley's Acre, Jordan's Acre and portions of the townlands of Demesne of Down, Quoile, Saul, Ballyvange, Quarter Cormick, Ballydugan and Ringreagh.

Ministry") on the 6th day of September, 1966, duly confirmed the Order made by the County Council:

And whereas the Rural District of East Down situated in the administrative County of Down is now divided into twenty-one district electoral divisions named respectively Ardglass, Ballynahinch Rural, Ballynahinch Urban, Castlewellan Rural, Castlewellan Urban, Clough, Crossgar, Downpatrick Rural, Dundrum, Dunmore, Inch, Killinchy, Killylough, Killyleagh Rural, Killyleagh Urban, Kilmore, Leggygowan, Raholp, Seaforde, Strangford and Tyrella:

And whereas it is expedient that the constitution of the district electoral divisions of Downpatrick Rural and Raholp should be altered in the manner hereinafter appearing:

Now therefore, the Ministry in exercise of its powers under the Local Government Acts (Northern Ireland) 1898 to 1964, and of all other powers in that behalf enabling the Ministry, hereby orders and directs as follows:

- (1) Save as hereinafter expressly provided the appointed day for the coming into effect of this Order shall be the 1st day of April, 1967: Provided that for the purposes of:
- the alteration or re-arrangement of any register of electors;
 - the alteration of valuation lists to take effect on the appointed day or the preparation or service of any precept to be made in respect of the financial year commencing on the appointed day; and
 - the preparation or approval of any general rate or special rate to be made in respect of a period commencing on the appointed day;

this Order shall have effect from the date of the making thereof.

- (2) Notwithstanding anything contained in any Order to the contrary the district electoral divisions of Downpatrick Rural and Raholp in the said Rural District shall consist of the townlands, parts of townlands and places set forth by name in Column 2 of the Schedule opposite to the names of such district electoral divisions.

And it is hereby declared that the foregoing provisions shall in no way affect or be deemed to affect the limits of any area heretofore determined by any Order to be the area of charge upon which any special expenses as defined by section 232 of the Public Health (Ireland) Act 1878, or any other expenses directed by any Act to be defrayed as such special expenses are and shall be chargeable.
