## INTOXICATING LIQUOR ACT (NORTHERN IRELAND), 1923.

NOTICE is hereby given that in pursuance of Clause 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by Section 1 of the Government Loans and Exchequer Provisions Act (Northern Ireland), 1925, and Section 1 of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, the Ministry of Finance for Northern Ireland has made Rules entitled the Intoxicating Liquor (Finance) Rules, 1926, governing the period within which advances made to the Claims Fund are to be repaid and the terms and conditions governing the repayment of such advances.
