# DEPARTMENT OF ECONOMIC AFFAIRS

### REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES

Pay of Chief and Senior Officers in the Local Government Service

Before the Prime Minister's request for a standstill on prices and incomes on 20th July, pay increases had been proposed for certain staff covered by the Joint Negotiating Committees for Town Clerks and District Council Clerks and for Chief Officers of local authorities in England and Wales and subsequently a claim has been made for Chief Officials of local authorities in Scotland.

In pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966 the First Secretary of State, the Secretaries of State for Scotland and Wales and the Minister of Housing and Local Government hereby refer to the National Board for Prices and Incomes for examination, concurrently with their examination of Chief and Senior Officers of the Greater London Council:

- (a) the salaries of staff subject to:
  - (i) the Joint Negotiating Committee for Clerks of County Councils in England and Wales;
  - (ii) the Joint Negotiating Committee for Town Clerks and District Council Clerks (England and Wales);
  - (iii) the Joint Negotiating Committee for Chief Officers of local authorities (England and Wales); and
  - (iv) the Joint Negotiating Committee for Chief Officials of local authorities (Scotland);
- (b) the salaries of the Clerks of County Councils in Scotland and their deputies.
- (c) the salaries of the Secretaries of County Councils, Town Clerks, Clerks to District Councils and Chief Officers of local authorities in Northern Ireland and their respective deputies;
- (d) the system for determining these salaries; and, in pursuance of their powers under section 2(3) of the Act, hereby withdraw the reference of the pay of chief and senior officers in the local government service published in the Gazette on 29th November. 5th December, 1966.

### EXPLANATORY NOTE

This reference adds to the questions referred to the Board and published in the Gazette on 29th November the salaries of the Clerks of County Councils in Scotland and their deputies.

#### **NEW TOWNS**

Order Establishing a New Town Commission
