The Regulations will modify the application of section 29 of the Act (Fire precautions—certification of premises) to certain buildings in which there are office or shop premises and also a factory (or part of a factory) within the meaning of the Factories Act (Northern Ireland) 1965 1965.

The draft regulations entitled the Office and Shop Premises (Modification of Fire Certification) Regu-lations (Northern Ireland) 1967, have been prepared and will be made under section 29(9) of the Act. # FACTORIES ACT (NORTHERN IRELAND) 1965

The regulations provide that only competent and properly trained persons shall prepare power presses for use; for the periodical examination of power presses and their safety devices; for the in-spection and test of safety devices after the tools have been set or re-set and before or during each working shift; for the marking of power presses and safety devices for purposes of identification; and for the marking on every power press constructed after the coming into operation of these regulations of the maximum permissible speed and the direction of the maximum permissible speed and the direction of rotation of the flywheel.
