THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

WHEREAS in pursuance of the powers conferred upon Him by the Treaties of Peace (Austria and Bulgaria) Act, 1920, His Majesty, in Council, was pleased to make the Treaty of Peace (Austria) Order, 1920, and various Orders amending the said Order:

And whereas it is expedient that the said Order, as amended, should be further amended in manner hereinafter appearing:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to

order, and it is hereby ordered, as follows:—
1. In the Treaty of Peace (Austria) Order, 1920 (as amended), for paragraph (xvi) of Article One thereof there shall be substituted the following paragraph:-

" (xvi) It shall be lawful for the Clearing Office or the Administrator to deduct from any sum payable by the Clearing Office or Administrator to a creditor or any other person such commission, not exceeding two and a half per cent. of the total amount paid or payable, as may be fixed by the Clearing Office or Administrator."

2. This Order may be cited as the Treaty of Peace (Austria) (Amendment) Order, 1925, and the Treaty of Peace (Austria) Orders, 1920 to 1924, and this Order may be cited together as the Treaty of Peace Orders, 1920 to 1925.

EXPLOSIVES ACT, 1875.
