THE REMUNERATION OF MILK DISTRIBUTORS

In July, 1965, the Central Milk Distributive Committee for England and Wales in association with the Scottish Milk Consultative Committee and the Federation of Northern Ireland Dairymen applied to the Minister of Agriculture, Fisheries and Food and to the Secretary of State for Scotland for a substantial but undefined increase as from 1st October 1965, in the remuneration of all sections of the milk distributive industry. Up to 30th September, 1966, the system of remuneration was based upon fixed guaranteed target rates of profit, which were subject to review. A decision on the application for an increase was deferred during the prices and incomes standstill. The Government now consider it desirable that, consistently with the guarantee arrangements for milk producers and Government control of distributive margins and retail milk prices, the National Board for Prices and Incomes should examine the methods and level of remuneration of distributors (other than producer-retailers) of liquid milk in the United Kingdom from the point of first sale by or through the agency of a Milk Marketing Board to the point of sale to the consumer, having regard to the need to promote economy, efficiency and productivity in milk selling and distribution.

#### PERFORMING RIGHT TRIBUNAL

Notice is hereby given, pursuant to Rule 5 of the Performing Right Tribunal Rules, 1965, of an application to the Tribunal under Section 27 of the Copyright Act, 1956, by the British Broadcasting Corporation, of Broadcasting House, Portland Place, London, W.1 (hereinafter called "the originator"). A copy of the application has been served on the Performing Right Society, Limited, of 29/33 Berners Street, London, W.1 (hereinafter called "the licensing body"). For the purpose of calculating the period of 42 days referred to in Rule 9 of the Rules, such service is deemed to have been effected on the 5th January, 1967.

The application concerns a dispute as regards the terms and conditions under which the licensing body is prepared to renew an earlier licence to the originator to broadcast, from sound broadcasting stations or as part of a television programme, copyright music controlled by the licensing body.

The originator objects to the increase in the royalty rate proposed by the licensing body. The proposed increase has been computed in relation to the current level of the cost of living and to the number of hours in which music controlled by the licensing body is broadcast by the originator. The notional figure reached in the light of these factors is then multiplied by the total number of sound and television receiving licences currently in existence, to give an overall royalty charge. The originator contends that, in fixing the royalty and other conditions, account should be taken of the reduction in the size of B.B.C. audiences which is alleged to have occurred in recent years as the result of the coming into existence of competing television and broadcasting services, and that the current number of receiving licences no longer forms an accurate indication of the size of such audiences.

Any organisation or person wishing to object to the credentials of the originator, or to be made a party to the proceedings, must make application for the purpose in the manner prescribed by the Performing Right Tribunal Rules, 1965, not later than the 10th February, 1967.
