### GOVERNOR OF NORTHERN IRELAND

#### THE STATUTE LAW COMMITTEE OF NORTHERN IRELAND

Whereas the Governor of Northern Ireland by Instruments given under his hand on the 10th day of March, 1924, and from time to time thereafter, has appointed a Statute Law Committee for Northern Ireland to perform the functions specified in the several Instruments.

And whereas of the Instruments so given there are now in force those given respectively on the 26th day of May, 1956, the 7th day of October, 1957, the 3rd day of November, 1961, and the 6th day of July, 1962.

And whereas it is expedient that the functions of the Committee be altered and that the Committee be reconstituted.

Now, therefore, I, John Maxwell, Baron Erskine of Rerrick, Knight Grand Cross of the Most Excellent Order of the British Empire, Governor of Northern Ireland, do hereby revoke the above-mentioned Instruments and do direct that the functions of the Statute Law Committee of Northern Ireland, be as follows:

- (a) to do all things necessary for the due superintendence of the publication of annual volumes and indices of the Statutes of Northern Ireland and the Statutory Rules and Orders of Northern Ireland; and
- (b) to make recommendations (whether in relation to some particular subject-matter or generally) with respect to the publication, revision, or consolidation of the Statutes of Northern Ireland and of statutory rules within the meaning of the Statutory Rules Act (Northern Ireland) 1958;

and do appoint the following persons to be the Statute Law Committee of Northern Ireland:

The Right Honourable the Lord MacDermott of Belmont, P.C., M.C., Lord Chief Justice of Northern Ireland (who shall act as Chairman of the said Committee);

The Honourable Mr. Justice Lowry, a Judge of the High Court of Justice in Northern Ireland;

The Right Honourable Edward Warburton Jones, P.C., Q.C., M.P., Her Majesty's Attorney-General for Northern Ireland;

Cecil Joseph Bateman, Esq., M.B.E., M.Comm.Sc., Permanent Secretary to the Ministry of Finance;

Sir Percy Faulkner, K.B.E., C.B., Controller of Her Majesty's Stationery Office;

James Alexander Brown, Esq., Q.C., Counsel to the Speakers of the two Houses of Parliament;
