## H.M. TREASURY

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 9 and 13 of, and Schedule 5 to, the Import Duties Act 1958, and Section 2(5) of the Finance Act 1965.

Viz: The Import Duty Drawbacks (No. 9) Order, 1967.

This Order:

- (i) extends the scope of the existing provisions for the allowance of drawback of import duty on imported materials used in the manufacture of exported chocolate and sugar confectionery, by adding dried egg albumin to the list of imported materials in respect of which drawback may be paid; and
- (ii) provides for the allowance of drawback of import duty on the exportation of:
  - (a) combing oil (a mixture of refined sperm oil, castor oil and fatty acids) manufactured from imported sperm oil and castor oil; and
  - (b) fatty alcohols manufactured from imported sperm oil.

This Order comes into operation on 5th October, 1967, and has been published as Statutory Instru-ments 1967, No. 1,435.

#### POST OFFICE CHARGES

The Post Office has under consideration changes in the charges both for postal services and for tele-communications services; both increases and de-creases would be involved. It is proposed that there

should be an important restructuring of the pattern of postal services, on the basis of replacing the present letter and printed paper services by a two-tier system providing for a first and second class letter service at differential tariffs. Some changes in the present basis of charging for telephone services the present basis of charging for telephone services are also in mind. In considering what will be needed the Post Office has had regard to the foreseen growth in business and in the size of the telephone growth in business and in the size of the telephone system, the expected increases in productivity, the requirements of the Post Office capital investment programme and its financial obligations. The new tariffs would take effect in the case of telecommuni-cations in the summer of 1968 and in the case of postal services in the autumn of 1968.

postal services in the autumn of 1968. The Government think it appropriate that these proposed changes should be examined by the National Board for Prices and Incomes. Accord-ingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Postmaster-General hereby refer the question of the proposed changes in Post Office charges to the National Board for Prices and Incomes for exam-ination on the assumption that the financial objec-tives of the postal and telecommunications services and the general programme of development for the industry are as as approved by the Government for the relevant period. 3rd October 1967
