- a representation by a body of 134 electors in the Dunmurry District Electoral Division in the South Antrim Constituency that Dunmurry District Electoral Division should not be transferred to the Belfast South constituency but should remain in the South Antrim constituency and that either the Cargin and Cranfield District Electoral Divisions or the Carrickfergus Rural and Ballynure Rural District Electoral Divisions be transferred from the South Antrim to the North Antrim constituency in the County of Antrim;
- (2) a representation by Mr. Stratton Mills, M.P.,

that a portion of the Cavehill Ward of Newtownabbey Urban District, containing 997 electors, now forming part of the South Antrim constituency should be transferred to and incorporated in the Belfast North constituency.
