MINISTRY OF AGRICULTURE, FISHERIES AND FOOD MERCHANDISE MARKS ACT 1926

Origin Marks on Pre-packed Cuts of Imported Meat

A Draft Order in Council embodying the recommendations of the Standing Committee set up by the Minister of Agriculture, Fisheries and Food, the Secretary of State for the Home Department and the Secretary of State for Scotland, on the labelling of Pre-packed Cuts of Imported Meat, has been laid before Parliament.

This Order would require all meat and edible offal when sold or exposed for sale in pre-packed form, whether wholesale or by retail, to bear the required indication of origin clearly and conspicuously marked in letters of not less than $\frac{3}{8}$ inch in height, provided that the net weight of the meat or edible offal in the container or package does not exceed 4 lb. at the time of sale or exposure for sale, and also that for all pre-packed meat the indication of origin should be permitted to appear, in the prescribed size of lettering, on each container or package of meat. The Poisons List (No. 2) Order adds certain substances to Parts I and 2 of the Poisons Schedule. The Poisons (No. 2) Regulations amend previous Poisons Regulations (S.R. & O. (N.I.) 1967 No. 143) so as to impose appropriate requirements and restrictions on the sale of substances which have been added to the Poisons Schedule.

The Poisons No. 3 Regulations provide that the purchase of an article by a person at the request of the Minister of Home Affairs or the Pharmacy Inspector for the purpose of securing compliance with the provisions of Part III of the Pharmacy and Poisons Act (N.I.) 1945 shall be deemed not to be a purchase within the meaning of paragraph (b) of sub-section (5) of Section 29 of the Act.

THE CLEAN AIR ACT (NORTHERN IRELAND) 1964

The Belfast (No. 1) Smoke Control Order (Northern Ireland) 1967

1. Notice is hereby given that the Belfast County Borough Council, acting by the Health Committee in exercise of the powers conferred on them by Section 11 of the above-mentioned Act, on the 24th day of October, 1967, made an Order entitled the Belfast (No. 1) Smoke Control Order (N.I.) 1967, declaring the area described in the schedule hereto to be a smoke control area, which order is about to be submitted to the Ministry of Health and Social Services for confirmation.

The authorised fuels include

anthracite, coke and other carbonised fuels, gas and electricity.

3. Copies of the Order and of the map referred to therein may be inspected free of charge at the Health Department, 16 College Street, Belfast, during the period of six weeks commenced on the 6th day of November, 1967, between the hours of 8.45 a.m. and 4.45 p.m. Monday to Friday.

4. Within the said period of six weeks any person who will be affected by the Order may by giving notice in writing to the Secretary, Ministry of Health and Social Services, Dundonald House, Belfast, BT4 3SF, object to the confirmation of the Order.
