ADMINISTRATION OF THE COLLEGE AND ITS ENDOWMENTS AND FINANCES

To provide for the Trustees' function in relation to the existing College lands and buildings and to the College Endowments, and that the Trustees shall be a body corporate with perpetual succession.

To provide for the appointment of Trustees, and the assumption of office of the reconstituted Board of Trustees.

To provide for the power of the Trustees to employ officers and employees, and the supplemental provisions set out in the Second Schedule.

To provide for the trusts applicable to the College Endowments and to declare those trusts, the main terms of which are:

- (a) to maintain the existing buildings, furniture and appliances of the College;
- (b) to pay outgoings and expenses in connection with the existing College premises;
- (c) to pay employees' wages and salaries;
- (d) to pay the students entitled thereto the amounts due for bursaries, exhibitions, scholarships and prizes;
- (e) to pay surplus endowment income to the University.

To provide for additional endowments received by the Trustees.

To provide for the housing of the books of the Magee Theological College in the College Library and for the access of students of the Magee Theological College thereto.

To provide for the transfer of certain Endowments to the Trustees of the Presbyterian Church in Ireland to be held by them on trust.

To provide for variation by the High Court of Justice in Northern Ireland of the terms of special trusts upon which any of the College Endowments are held.

To provide for the alteration of the trusts declared by the Will and three Codicils of Basil McCrea, as modified by the Basil McCrea Endowments Act (Northern Ireland) 1923.

To provide for liberty to the Trustees to transfer the premises situate at 5 and 6 Crawford Square, Londonderry, and known as the Peace Thanksgiving Hostel and the funds and investments known as the Peace Thanksgiving Fund to the Trustees of the Presbyterian Church in Ireland to be held upon trusts for the user thereof as a residential hostel for students.

To provide for the application of the College Endowments if the College shall cease to be an integral part of the University or if the College lands and premises cease to be used for University education.

GENERAL.
