### A PROCLAMATION

DETERMINING NEW DESIGNS FOR  
CUPRO-NICKEL AND BRONZE COINS

ELIZABETH R.

Whereas under section 11 of the Coinage Act 1870 We have power, with the advice of Our Privy Council, from time to time by Proclamation to determine the design for any coin:

And Whereas it appears to Us desirable, in consequence of the passing of the Decimal Currency Act 1967, to determine designs for the coins hereinafter specified, being coins of the denominations described in Schedule 1 to that Act:

And Whereas, by virtue of section 2(4) of the said Act of 1967, We have power, by Proclamation under section 11 of the said Act of 1870, to direct that coins made in accordance with section 2 of the said Act of 1967 may be issued for use before the day appointed under section 1(2) of that Act as current coins of such denominations as may be specified:

We, therefore, in pursuance of section 11 of the Coinage Act 1870, as extended by section 2(4) of the Decimal Currency Act 1967, and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

The designs for the cupro-nickel and bronze coins of the denominations described in Schedule 1 to the Decimal Currency Act 1967 shall be as follows:

#### CUPRO-NICKEL COINS

(1) Ten new pence—Every ten new pence shall have for the obverse impression Our effigy with the inscription "D·G·REG·F·D·ELIZABETH·II" and the date of the year, and for the reverse a lion passant guardant royally crowned, being part of the crest of England, and the inscription "10 NEW PENCE". The coin shall have a graining upon the edge.

(2) Five new pence—Every five new pence shall have the same obverse impression and inscription as the ten new pence, and for the reverse a thistle royally crowned, being the badge of Scotland, and the inscription "5 NEW PENCE". The coin shall have a graining upon the edge.

#### BRONZE COINS

(1) Two new pence—Every two new pence shall have for the obverse impression Our effigy with the inscription "D·G·REG·F·D·ELIZABETH·II"

and the date 1971, or of a succeeding year, and for the reverse the badge of the Prince of Wales, being three ostrich feathers enfiling a coronet of crosses pattée and fleurs de lys with the motto "ICH DIEN", and the inscription "2 NEW PENCE". The coin shall have a plain edge.

(2) New penny—Every new penny shall have the same obverse impression and inscription as the two new pence, and for the reverse a portcullis with chains royally crowned, being a badge of King Henry VII and his successors, and the inscription "1 NEW PENNY". The coin shall have a plain edge.

(3) New halfpenny—Every new halfpenny shall have the same obverse impression and inscription as the two new pence, and for the reverse the Royal Crown, and the inscription "½ NEW PENNY". The coin shall have a plain edge.

The ten new pence and the five new pence may be issued for use before the day appointed under section 1(2) of the Decimal Currency Act 1967 as a florin and a shilling respectively.

This Proclamation shall come into force on the seventeenth day of February One thousand nine hundred and sixty-eight.

Given at Our Court at Buckingham Palace, this fourteenth day of February, in the year of our Lord One thousand nine hundred and sixty-eight, and in the seventeenth year of Our Reign.

## DEPARTMENT OF ECONOMIC AFFAIRS

### PRICES AND INCOMES ACT 1966

*Reference to the National Board for Prices  
and Incomes*

#### DOMESTIC APPLIANCES

The Minister of Technology has recently been notified by Hoover Limited under the early warning arrangements of proposed increases in the prices of a wide range of domestic appliances. The reasons for the increases are the general increases in costs which have occurred since prices were last fixed and, to some extent, the extra costs arising from devaluation.

The Secretary of State for Economic Affairs and the Minister of Technology consider that it would

be desirable for the case for the increases in prices proposed to be examined independently by the National Board for Prices and Incomes.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Technology hereby refer to the National Board for Prices and Incomes for examination the question of the increases in the prices of domestic appliances proposed by Hoover Limited.

#### MERCURY HEARING-AID BATTERIES

The Ministry of Technology were notified in December, 1967, by Mallory Batteries Ltd., under the early warning arrangements of proposed increases in the prices of a wide range of special batteries. Among these were hearing-aid batteries, the prices of which had remained unchanged for several years while the manufacturing costs had risen substantially in the same period.

The increase in the prices of hearing-aid batteries has given rise to a large volume of public complaint. In the circumstances the Secretary of State for Economic Affairs and the Minister of Technology consider that it would be desirable for the case for the increase in price to be examined independently by the National Board for Prices and Incomes.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act, 1966, the Secretary of State for Economic Affairs and the Minister of Technology hereby refer to the National Board for Prices and Incomes for examination the question of the recent increase in prices of mercury hearing-aid batteries manufactured by Mallory Batteries Limited.

#### SECONDARY BATTERIES

The Minister of Technology has recently been notified by a number of manufacturers under the early warning arrangements of proposed increases in the prices of certain types of secondary batteries to take account of increases in costs, including increases due to devaluation, since these companies, in common with other battery manufacturers, reduced their prices last year. The batteries in question are secondary lead-acid replacement batteries used for starting, lighting and ignition purposes on road vehicles.

The Secretary of State for Economic Affairs and the Minister of Technology consider that it would be desirable for these proposals for increases in prices to be examined independently by the National Board for Prices and Income.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act, 1966, the Secretary of State for Economic Affairs and the Minister of Technology hereby refer to the National Board for Prices and Incomes for examination the question of increases in manufacturers prices of these types of secondary batteries, including consequential increases in recommended resale prices.

#### PRICE OF BUTYL RUBBER

The price of butyl rubber manufactured by ESSO Chemical Limited has been increased, following devaluation, from 21½d. per lb. to 25d. per lb. In view of the importance of this material to the rubber manufacturing industry, the Secretary of State for Economic Affairs and the President of the Board of Trade consider it desirable that the justification for the price increase should be independently examined by the Board.

Accordingly, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act, 1966, the Secretary of State for Economic Affairs and the President of the Board of Trade hereby refer to the National Board for Prices and Incomes for examination the question of the increase in the price of butyl rubber.
