## MINISTRY OF FINANCE

WHEREAS under section 1(3) of the Ministries of Northern Ireland Act (Northern Ireland) 1921, the Minister of Finance may, if he thinks fit, by minute to be laid before both Houses of Parliament assign any specified powers or duties of the Ministry of Finance to such officer as he may appoint to exercise or perform the same:

And Whereas by Minute dated the 20th day of May, 1965, the Minister of Finance appointed Walter Gilliard Nicholl, an officer of the Ministry, to exercise and perform the powers and duties of Registrar General of Births, Deaths and Marriages for Northern Ireland:

And Whereas it is expedient to appoint James Young Malley, an officer of the Ministry, to act as Registrar of Births, Deaths and Marriages for Northern Ireland in place of Walter Gilliard Nicholl.

Now I, The Right Honourable Herbert Victor Kirk, Minister of Finance for Northern Ireland, in pursuance of the power vested in me as aforesaid and of all other powers me thereunto enabling do by this Minute revoke the said Minute of 20th May, 1965, and by this Minute appoint as from the 12th May, 1969, and until further notice by me, the said James Young Malley to be Registrar General of Births, Deaths and Marriages for Northern Ireland, to exercise and perform the powers and duties of the said office which powers and duties I hereby assign to him.

### *Ulster Savings Certificates*

The Ministry of Finance has made an Order (S.R. & O. (N.I.) 1969, No. 111) extending the currency of the Ulster Savings Certificates of the TENTH ISSUE for a further six years, i.e. from six years to twelve years, with interest at the rate of one shilling per year for each unit certificate and an additional one shilling per unit certificate at the end of the twelfth year.

## MINISTRY OF AGRICULTURE

### DEVELOPMENT LOANS (AGRICULTURE AND FISHERIES) ACT (NORTHERN IRELAND) 1968

#### *Agricultural Development Loans*

It has been decided that as from 12th May, 1969, the rate of interest charged on Agricultural Machinery Loans shall be increased to 11½ per cent, and that the rate of interest charged on all other agricultural loans shall be increased to 9½ per cent.

The new rates will apply to loans approved on or after the above date.

### AGRICULTURAL RETURNS ACT (NORTHERN IRELAND) 1939

Under Section 1 (1) of the above-mentioned Act every person occupying agricultural land and/or owning livestock is required to furnish to the Ministry of Agriculture on demand returns showing certain particulars in respect of the land and/or livestock as on prescribed days.

### WEIGHTS AND MEASURES ACT (NORTHERN IRELAND) 1967

Notice is hereby given that the Ministry of Commerce in exercise of the powers conferred upon it by the Weights and Measures Act (Northern Ireland) 1967 has made the following Statutory Rule:

The Weights and Measures (Amendment) Regulations (Northern Ireland) 1969, No. 114. These regulations which will come into operation on 14th May, 1969, amend the Weights and Measures Regulations (Northern Ireland) 1967. They provide for the conversion of price computing mechanisms on weighing machines to indicate prices in decimal currency without the stamps having to be obliterated by an Inspector of Weights and Measures. Notice must be given to the Chief Inspector within 15 days of making the alteration. If this requirement is met stamps on such instruments will not need to be obliterated merely because they have been altered to show decimal currency.

The new Regulations also extend for a further five years the period during which metric weights marked with the abbreviation "grm." may be used and permit the continued re-stamping of bell weights of a type in use prior to the introduction of the bell weights described in the Weights and Measures Regulations 1967.
