CALLING IN ALL HALFPENNIES

ELIZABETH R.

Whereas under section 11 of the Coinage Act 1870 We have power, with the advice of Our Privy Council, by Proclamation to call in coins of any date or denomination:

And Whereas it now appears to Us desirable to call in all halfpennies:

We, therefore, with the advice of Our Privy Council and in pursuance of section 11 of the Coinage Act 1870, do hereby call in by the thirty-first day of July One thousand nine hundred and sixtynine all halfpennies, and direct that after such thirtyfirst day of July One thousand nine hundred and sixty-nine such coins shall not be current or legal tender within Our United Kingdom of Great Britain and Northern Ireland.

Given at Our Court at Buckingham Palace, this twenty-fifth day of June in the year of our Lord One thousand nine hundred and sixty-nine and in the eighteenth year of Our Reign.
