DIPLOMATIC IMMUNITIES (CONFERENCES WITH COMMONWEALTH COUNTRIES AND REPUBLIC OF IRELAND) ACT 1961

- 2. And whereas by section 5(3) of the Act, but subject to section 5(4), the Board are required to make their report so as to allow publication within three months of the said date;
- 3. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under the said section 5(4) hereby direct that the said period of three months be extended by three months.

And whereas, in pursuance of her powers under the said section 5(4), the First Secretary of State and Secretary of State for Employment and Productivity, by a direction published in the Gazette on 25th February, 1969, extended the said period of three months by three months and by a direction published in the Gazette on 22nd May, 1969, further extended the said period of three months by two months;
- 4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under the said section 5(4), hereby directs that the said period of three months be further extended by one month.

DECIMAL CURRENCY ACT 1969
