Reference to the National Board for Prices and Incomes of a proposal by the Cement Makers' Federation to increase the price of Portland Cement

The Cement Makers' Federation has given advance notice under the early warning arrangements of its proposal to raise by 12s. 0d. per ton the prices currently charged for Portland Cement by its members under their common price arrangement. The First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Public Building and Works consider it desirable that this proposal should be the subject of an independent investigation by the National Board for Prices and Incomes.

Ltd., Aberthaw and Bristol Channel Portland Cement Co. Ltd., Ribblesdale Cement Ltd., Ketton Portland Cement Co. Ltd., and Imperial Chemical Industries Ltd.

THE CLEAN AIR ACT (NORTHERN IRELAND) 1964

The Belfast (No. 7) Smoke Control Order (N.I.) 1969
