MINISTRY OF POWER

THE PETROLEUM (PRODUCTION) REGULATIONS 1966

The Minister of Power is prepared to receive between 9 a.m. on 24th September 1969 and 6 p.m. on 15th January 1970 applications in accordance with the Petroleum (Production) Regulations 1966 (S.I. 1966, No. 898) for production licences in respect of the blocks to which the numbers specified in the schedule to this notice have been assigned on a map deposited at the Ministry of Power, Thames House, South, Millbank, London, S.W.1. The map may be inspected on request during the said period between the hours of 9.30 a.m. and 5 p.m. except on Saturdays, Sundays and public holidays, Copies of the map may be inspected by prior appointment at the offices of the Ministry of Power at 71 George Street, Edinburgh 2 and Government Buildings Gabalfa, Cardiff, and at the Ministry of Commerce, 21 Linenhall Street, Belfast. In considering any application received during the said period the Minister will not take account of the day on which it was received.

- 2. To assist the Minister in considering the applications, applicants are invited to indicate in as much detail as practicable the degree of preference which they attach to the blocks to which their application relates.
- 3. Following is a summary of the consideration which the Minister, with the consent of the Treasury, has decided to require in respect of production licences granted in response to applications made during the said period.
- (1) Upon the grant of the licence the sum of thirty pounds for each square kilometre comprised in the licensed area.
- (2) In respect of the first year from the date of surrender of part of the licensed area (on exercise of the option to continue as to the remainder), the sum of fifty pounds for each square kilometre in the continuing part; in respect of the second year eighty pounds, and similarly by annual increments of thirty pounds until an annual sum of three hundred and fifty pounds will be payable for each square kilometre comprised in the licensed area.
- (3) A royalty at the rate of twelve and a half per cent by value, from which may be deducted the periodic payments mentioned in (2) above.

PRICES AND INCOMES ACT 1966

AN AGREEMENT RELATING TO THE SALARIES OF CERTAIN STAFF EMPLOYED BY BRITISH INSULATED CALLENDER'S CABLES LIMITED AND CERTAIN OTHER COMPANIES

PUBLIC ORDER ACT (NORTHERN IRELAND) 1951

Whereas I, The Right Honourable Robert Wilson Porter, Q.C., M.P., Minister of Home Affairs, am of the opinion that by reason of the unrest and tension at present existing among certain sections of the community serious public disorder will be occasioned should any further public processions or meetings be held in Northern Ireland.

And Whereas I am further of the opinion that the powers exercisable under Section 2(1) of the Public Order Act (Northern Ireland) 1951 will not be sufficient to prevent serious public disorder being occasioned by the holding of such processions or meetings.

Now, Therefore, I, The Right Honourable Robert Wilson Porter, Q.C., M.P., Minister of Home Affairs, in exercise of the powers conferred upon me by Section 2(2) of the Public Order Act (Northern Ireland) 1951, do hereby order that the holding of all public processions and outdoor meetings (other than a procession or meeting held by the Salvation Army) in any public place in Northern Ireland is prohibited for the period commencing on 1st October, 1969, and ending on 31st December, 1969.

Nothing in this Order shall affect the operation of the Order made by me on the 29th August, 1969.
