"With our humble duty my Ministers and I, in the name and on behalf of the people of Northern Ireland, proffer loyal greetings to The Queen on the occasion of the official celebration of Her Majesty's birthday. We shall be grateful if you will assure Her Majesty of Ulster's special affection for Her and Her Family and our best wishes for Her continued health and happiness."

#### POLICE ACT (NORTHERN IRELAND) 1970

#### POLICE AUTHORITY

I, Ralph Francis Alnwick, Baron Grey of Naunton, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Officer of the Most Excellent Order of the British Empire, Governor of Northern Ireland, in pursuance of the powers vested in me by Section 1 of and Schedule 1 to the Police Act (Northern Ireland) 1970, do hereby appoint the persons named in the Schedule to be members of the Police Authority for a period of three years from the 29th June, 1970.

And I further appoint Brigadier Sir Ian Fraser, D.S.O., O.B.E., F.R.C.S., D.L., and Frank Edward Benner, Esq., D.L., to be, respectively, Chairman and Vice Chairman of the said Authority.
