## BY THE QUEEN A PROCLAMATION

REVOKING A PROCLAMATION, DATED THE 16TH DAY OF JULY, 1970, DECLARING THE EXISTENCE OF A STATE OF EMERGENCY

#### ELIZABETH R.

Whereas by Our Proclamation, dated the sixteenth day of July, nineteen hundred and seventy, We declared that a state of emergency existed within the meaning of the Emergency Powers Act 1920, as amended by the Emergency Powers Act 1964:

And whereas it appears to Us that the state of emergency has now ceased to exist and that it is expedient that the said Proclamation should be revoked accordingly:

Now, therefore, We do, by and with the advice of Our Privy Council, hereby proclaim that the said Proclamation is revoked.

Given at Our Court at Buckingham Palace this fourth day of August, in the year of our Lord nineteen hundred and seventy, and in the nineteenth year of Our Reign.

#### RESTRICTION ON INSURANCE COMPANY

## CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND) 1922 to 1943

I, The Right Honourable Robert Wilson Porter, Q.C., M.P., Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Acts (Northern Ireland) 1922 to 1943, in exercise of the powers conferred on me by Regulation 39 of the Regulations made under the authority of the said Acts, do hereby make the following Order:

All premises licensed under the provisions of the Licensing Acts (Northern Ireland) and all premises registered under the provisions of the Registration of Clubs Acts (Northern Ireland) 1967 which are situated within the County Borough of Belfast shall be closed each day from the hour of 8 p.m. for the supply or sale or consumption of intoxicating liquor.

Provided that, in relation to Hotels, Theatres, Restaurants and Registered Clubs, the closing hour so fixed shall apply only to the supply or sale or consumption of intoxicating liquor and not to the premises.

This Order shall come into operation on 3rd August, 1970, and shall remain in force until revoked by a further Order.
