# CIVIL AUTHORITIES (SPECIAL POWERS) ACTS NORTHERN IRELAND) 1922 TO 1943

I, The Right Honourable Robert Wilson Porter, Q.C., Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Acts (Northern Ireland) 1922 to 1943, in exercise of the powers conferred on me by Regulation 39 of the Regulations made under the authority of the said Acts, do hereby make the following Order:

# CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND) 1922-43

## GAME LAW (AMENDMENT) ACT (NORTHERN IRELAND) 1951

The Game Preservation (Partridge and Hen Pheasant Order (Northern Ireland) 1970, No. 215.

The Order permits those persons who have been granted exemption to kill hen pheasants to sell the birds killed under the terms of the exemption to a licensed game dealer.
