SUPREME COURT NORTHERN IRELAND

PROCEDURE

THE RULES OF THE SUPREME COURT (NORTHERN IRELAND) (No. 1) 1970

Notice is hereby given that on 2nd June, 1970, the Northern Ireland Supreme Court Rules Committee in exercise of the powers conferred by section 7 of the Northern Ireland Act 1962, made the Rules of the Supreme Court (Northern Ireland) (No. 1) 1970 (S.R. & O. 1970, No. 163).

These Rules amend the Rules of the Supreme Court (Northern Ireland) 1936 in relation to bank-ruptcy procedure and practice.

Rule 3 substitutes for rules 1-212 of Order LXXXVIII, the rules in Schedule 1 to these Rules. The rules in this Schedule make important changes in the present procedure in Bankruptcy and are intended to make detailed information on bankruptcy practices and procedure more easily available.

The following are important changes made by these rules:

- (1) The functions of the Official Assignee are enlarged to include conducting, by an examiner of his Department, a preliminary examination of every bankrupt, the examination of every creditor's claim and investigation, where necessary, before proof of debts sittings are held and a power of sale over the assets of a bankrupt or of an arranging debtor vested in the Official Assignee, without the leave of the Court (rules 73, 162, and 144(4)).
- (2) All Press advertising is discontinued unless specially directed by the Registrar.
- (3) The length of time occupied by the public examination of bankrupts will be reduced in uncontroversial cases by allowing the notes taken by the Official Assignee's examiner at the preliminary examination to be adopted by the bankrupt as his evidence after being read in open Court and signed by the bankrupt (rule 75).
- (4) Where a bankrupt proposes an offer of composition a preliminary meeting of creditors is required under rule 87, unless the bankrupt proposes to pay all his creditors in full.

Rule 6 substitutes for Forms 1-35 and 50-54 in Appendix Y the new Forms set out in Schedule 2. These Forms include a form of affidavit grounding a petition of arrangement (Form 71). A copy of this Form will be filed in the Bills of Sale Office under the Deeds of Arrangement Amendment Act 1890

and the separate affidavit at present required by Order LXXXII rule 7, is dispensed with.

These rules come into force on 1st January, 1971.

 - The Order made by me on the 3rd August, 1970 with respect to the closing of licensed premises and registered clubs within the County Borough of the City of Belfast at 8 o'clock p.m. each day is hereby revoked with effect from and including Monday, 17th August, 1970.
 - 3. Article 1 shall not apply to the sale, purchase, consumption or permitting the consumption of intoxicating liquor in an hotel if such liquor is sold to a resident in that hotel for consumption by him in a room or part of the hotel exclusively reserved for residents in the hotel.
 - This Order shall remain in force until revoked by a subsequent Order.
