Whereas by section 1 of the Emergency Powers Act 1920, as amended by the Emergency Powers Act 1964, it is enacted that if it appears to Us that there have occurred or about to occur events of such a nature as to be calculated, by interfering with the supply and distribution of food, water fuel or light, or with the means of locomotion, to deprive the community, or any substantial portion of the community, of the essentials of life, We may, by Proclamation, declare that a state of emergency exists:

And whereas the present industrial dispute affecting persons employed in the electricty supply industry does, in Our opinion, constitute a state of emergency within the meaning of the said Act of 1920, as so amended:

Now, therefore, in pursuance of the said Act of 1920, as so amended, We do, by and with the advice of Our Privy Council, hereby declare that a state of emergency exists.

Given at Our Court at Buckingham Palace this twelfth day of December, in the year of our Lord one thousand nine hundred and seventy, and in the nineteenth year of Our Reign.

Now, therefore, We do, by and with the advice of Our Privy Council, hereby proclaim that the said Proclamation is revoked.

Given at Our Court at Buckingham Palace this seventeenth day of December in the year of our Lord one thousand nine hundred and seventy, and in the nineteenth year of Our Reign.

Now, Therefore, I, Ralph Francis Alnwick, Baron Grey of Naunton, Knight Grand Cross of the Most Distinguished Order of St. Michael and St. George, Knight Commander of the Royal Victorian Order, Officer of the Order of the British Empire, Governor of Northern Ireland, do, by and with the advice of the Privy Council of Northern Ireland and in pursuance of the said Acts and of all other powers me thereunto enabling, hereby declare that such a state of emergency exists.

This Order reduces the import duty on unsweetened canned pears from 15% to 5% ad valorem for a period of six months.

This Order:

- 1. extends the period for which drawback of import duty is allowed on the exportation of certain imported ceramic products and glassware;
- 2. revokes the provisions for drawback of import duty in respect of imported:
 - a. melon and citrus fruit peel and menthol not synthetic used in the manufacture of exported chocolate and sugar confectionery;
 - b. cocoa beans and paste used in the manufacture of exported cocoa butter, cake, powder and paste;
 - c. hazelnuts used in the manufacture of exported hazelnut products;
 - d. goat and kid skins used in the manufacture of exported dressed leather; and
 - e. soya beans used in the manufacture of exported soya bean oil and products;
- 3. revises the rates of drawback of import duty in respect of:
 - a. oat products manufactured from imported oats;
 - b. electrosensitive recording paper manufactured from imported wet-strengthened cellulose paper; and
 - c. certain sugar and sugar products manufactured from imported sugar;
- 4. Substitutes, from 15th February onwards, the decimal equivalent in cases where a fixed rate of drawback of import duty is payable;
- 5. removes the bar to drawback relief for certain goods manufactured from imported materials where the duty paid does not exceed a fixed amount per unit of quantity or weight;
- 6. revokes the fixed rate of drawback of import duty in respect of exported fibreboard packing cases manufactured from imported kraft paper or board and provides for drawback to be related to the duty paid on the quantity of imported paper or board actually used in their manufacture.

The Order comes into operation on 1st January, 1971 and has been published as Statutory Instrument 1970, No. 1818.
