HONOURS AND AWARDS

CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD

St. James's Palace, London S.W.1.
22nd June 1971.

The QUEEN has been graciously pleased to approve the posthumous award of the George Cross to:

23910067 Sergeant Michael WILLETTS, The Parachute Regiment.

At 8.24 p.m. on the evening of 25th May, 1971, a terrorist entered the reception hall of Springfield Road Police Station in Belfast. He carried a suitcase from which a smoking fuse protruded, dumped it quickly on the floor and fled outside. Inside the room were a man and a woman, two children and several police officers.

One of the latter saw at once the smoking case and raised the alarm. The Police Officers began to organise the evacuation of the hall past the reception desk, through the reception office and out by a door into the rear passage.

Sergeant Michael Willetts was on duty in the inner hall. Hearing the alarm, he sent an N.C.O. up to the first floor to warn those above and hastened himself to the door towards which a Police Officer was thrusting those in the reception hall and office. He held the door open while all passed safely through and then stood in the doorway, shielding those taking cover. In the next moment, the bomb exploded with terrible force.

Sergeant Willetts was mortally wounded.

His duty did not require him to enter the threatened area; his post was elsewhere. He knew well after 4 months' service in Belfast, the peril of going towards a terrorist bomb but he did not hesitate to do so. All those approaching the door from the far side agree that if they had had to check to open the door they would have perished. Even when they had reached the rear passage, Sergeant Willetts waited, placing his body as a screen to shelter them. By this considered act of bravery, he risked—and lost—his life for those of the adults and children. His selflessness, his courage are beyond praise.

George Medal

Edward Henry NURSE, Inspector, Royal Ulster Constabulary.

British Empire Medal for Gallantry (Civil Division)

John Douglas WILSON, Sergeant, Royal Ulster Constabulary.

Hugh SHAW, Constable, Royal Ulster Constabulary.

On the evening of 25th May, Inspector Nurse was the Duty Inspector of Springfield Sub-Division at Springfield Road Police Station, Sergeant Wilson and Constable Shaw were also on duty at the same time. A terrorist entered the Police Station by the Police entrance and threw a smoking case full of explosives into the reception hall. The hall at this time had six people in it, including two children. The bomb was instantaneously spotted by Wilson and Shaw who recognising the appalling danger in which everyone stood immediately raised the alarm and started to move the people out of the hall. Inspector Nurse organised the rapid evacuation of everyone present. In the face of great imminent danger he remained in the Reception Hall until he had satisfied himself that everyone was clear. Having got the children away as far as possible he threw himself over them in order to shield them from the blast which caused him numerous lacerations to the back of the legs, body and head. His gallant and selfless act was in the highest traditions of the Royal Ulster Constabulary. The prompt and effective actions of Sergeant Wilson and Constable Shaw, with no thought for their own safety, ensured the orderly evacuation of the hall.

Awarded the British Empire Medal for Gallantry (Civil Division):

Henry BRENNAN, Constable, Royal Ulster Constabulary, Coleraine, Co. Londonderry.

The Police were called to investigate the theft of a pedal cycle. A man was seen turning into an entry leading to a wall in which were a number of doors affording access to the rear of some houses. Constable Brennan climbed on to this wall and with the aid of his torch began an examination of the enclosed yards down below. He had only gone a short

distance when he was suddenly confronted by a man wearing a mask and pointing a gun at him. The man told him to get down off the wall or he would shoot. The Constable did as he was told and meanwhile the gunman came through the doorway and was waiting as he alighted. He had the gun pointed at the Constable's back and as the Constable moved forward the gunman moved with him. He told Constable Brennan to throw down his torch and the Constable complied but as he did so he swung round and grappled with the gunman striking him with his baton on the hand in which he held the gun. In ensuing struggle both fell to the ground and the gunman was eventually overpowered and disarmed.

SUPREME COURT, NORTHERN IRELAND

PROCEDURE RULES OF THE SUPREME COURT (NORTHERN IRELAND) (No. 2) 1971

Notice is hereby given that on 26th May, 1971, the Northern Ireland Supreme Court Rules Committee in exercise of the powers conferred by section 7 of the Northern Ireland Act 1962 made the Rules of the Supreme Court (Northern Ireland) (No. 2) 1971 S.R. & O. (Northern Ireland) 1971 No. 153.

These rules make certain miscellaneous amendments to the Rules of the Supreme Court (Northern Ireland) 1936.

Rule 1 changes the Roman numerals used to designate the number of each Order in the Rules of the Supreme Court to Arabic numerals.

Rules 2 to 4 assign to the Chancery Division all actions in which there is a claim for payment of principal money secured by any mortgage or charge or a claim for delivery of possession of any property forming a security for payment of any principal money or interest, and change the procedure for filing judgment in such actions in default of appearance or defence. An application must be made to the Court or a Judge for leave.

Rule 5 inserts a new Order 54F which relates to application under the Northern Ireland (Remittal and Removal of Proceedings) Order 1971 which establishes the procedure to be followed in the remittal of an action to the County Court or the removal of a County Court action to the High Court.

Rule 7 makes provision for witnesses' expenses and pre-trial consultations, and for the recovery of costs in proceedings commenced in the High Court which could have been brought in the County Court.

These rules came into force on 14th June, 1971, with the exception of rule 7(2) which comes into force on 1st October, 1971, and makes provision in relation to the recovery of costs and proceedings commenced in the High Court which could have been brought in the County Court.

REGULATIONS 1966

THE PETROLEUM (PRODUCTION) (AMENDMENT) REGULATIONS 1971

The Secretary of State for Trade and Industry is prepared to receive applications in accordance with the Petroleum (Production) Regulations 1966 (S.I. 1966 No. 898) as amended by the Petroleum (Production) (Amendment) Regulations 1971 (S.I. 1971 No. 814) for petroleum production licences in respect of the blocks to which the numbers specified in the Schedules to this notice have been assigned on a map deposited at the Department of Trade and Industry (Petroleum Division), Thames House South, Millbank, London SW1. The map may be inspected by prior appointment (Tel. 01 222 7000 Extension 1227) between 0930 and 1700 hours Monday to Friday from 23rd June to 20th August, 1971. Copies of the map may also be inspected by prior appointment at the offices of the Department of Trade and Industry at 71 George Street, Edinburgh 2 (Tel. 031-225 1822) and Government Buildings, Gabaifa, Cardiff (Tel. 0222 62131 Extension 735) and at the Ministry of Commerce, Chichester House, Chichester Street, Belfast (Tel. Belfast 34488 Extension 413).

2 The consideration required in respect of production licences granted as a result of this invitation will be:

- (1) in respect of all blocks listed in the Schedules:
 - (a) upon the grant of the licence an initial payment of forty five pounds for each square kilometre comprised in the licensed area;
 - (b) in respect of the first year from the date of surrender of part of the licensed area (on exercise of the option to continue as to the remainder) the sum of fifty pounds for each square kilometre in the continuing part; in respect of the second year eighty pounds, and similarly by annual increments of thirty pounds until an annual sum of three hundred and fifty pounds will be payable for each square kilometre comprised in the licensed area;
 - (c) a royalty at the rate of twelve and a half per cent by value on all quantities of petroleum won and saved, from which may be deducted the periodic payments mentioned in (b) above;

- (2) in respect only of blocks listed in Schedule II, an additional initial payment or premium for each such block.

3 In certain cases, blocks have been combined to form a parcel of blocks. In these cases, applications will be entertained only in respect of whole parcels and for the purpose of calculating the application fees payable each such parcel will be counted as a single block.

4 Licences granted for blocks marked * may be subject to special conditions governing the notice required for, and the timing and circumstances of, drilling.

5 All applicants must be either citizens of the United Kingdom and Colonies resident in the United Kingdom, or bodies corporate incorporated in the United Kingdom.

6 In respect of the blocks listed in Schedule I:

- (1) applications shall be delivered during normal business hours between 0930 hours on 23rd June, 1971 and 1200 hours on 20th August, 1971 to the Department of Trade and Industry at Thames House South, Millbank, London SW1, together with a payment in respect of the application fee calculated in accordance with Regulation 11(2) of the Petroleum (Production) Regulations 1966;
- (2) to assist the Secretary of State in the examination of applications, applicants are invited to indicate in as much detail as practicable the degree of preference which they attach to the blocks to which their application relates;
- (3) the considerations (inter alia) the Secretary of State will have in mind in examining applications will be:
 - (a) where a body corporate incorporated in a country outside the United Kingdom holds a controlling interest in the applicant, the extent to which equitable reciprocal treatment is accorded in such other country;
 - (b) the extent to which the applicant will further the thorough and rapid exploration of the oil and gas resources of the United Kingdom Continental Shelf, particular attention being paid to the financial and technical ability of the applicant to carry out an acceptable work programme, details of which will be called for when required during the consideration of the applications;
 - (c) exploration work already done by or on behalf of the applicant which is relevant to the areas applied for;
 - (d) where the applicant already holds a production licence or licences, his overall performance to date;
 - (e) the extent of the contribution which the applicant has made or is planning to make to the economy of the United Kingdom including the strengthening of the United Kingdom balance of payments and the growth of industry and employment.

7 The Secretary of State will advise applicants of his decision in due course.

8 In respect of the blocks listed in Schedule II:

- (1) application shall be by way of tender submitted on a special form and delivered by hand enclosed in a plain envelope having a special label to the Treasury Solicitor's Department, Room 1247, Thames House South, Millbank, London SW1 between 1000 and 1200 hours on 20th August, 1971. Copies of the special tender form and label may be obtained from the address given in paragraph 1 above;
- (2) the tender shall quote separately in respect of each block applied for, the amount in sterling of the additional initial payment or premium tendered;
- (3) tenders transferable between blocks will not be accepted;
- (4) the envelope enclosing each tender shall also contain:

- (a) a deposit in sterling of 20 per cent of the premium offered in the form of a certified cheque or a bank draft made payable to the Department of Trade and Industry and drawn on a bank which is a member of the Committee of London Clearing Bankers; and
- (b) a separate payment in respect of the application fee calculated in accordance with Regulation 11(2) of the Petroleum (Production) Regulations 1966;
- (5) no specific work programme need be stated in the tender;
- (6) tenders received in response to this invitation will be opened at 1400 hours on 20th August, 1971 at Thames House South, Millbank, London, SW1; awards will not be announced at that time but will be made known later. Arrangements will be made for representatives of each tenderer, should they so wish, to be present at the opening of the tenders;
- (7) the Secretary of State reserves the right to reject the highest or any other tender, on all or any of the following grounds:
- (a) where the tender has been submitted by a body corporate, a controlling interest in which is held by a body corporate incorporated in a country outside the United Kingdom if he is not satisfied that equitable reciprocal treatment is accorded in such other country;
- (b) where the applicant has not observed all or any of the provisions of paragraph 5 or sub-paragraphs (1) to (4) of this paragraph;
- (c) if he is not satisfied that the applicant has at his disposal the necessary technical resources to carry out a work programme competently;
- (d) for any other reason, in which case the reason for doing so will be given to the applicant on request;
- (8) subject to the Secretary of State's right in accordance with the discretions described above to accept or reject any tender, licences will be awarded to the highest tenderers; in the event of the highest or other acceptable tenders being equal, the tenderers or (if tenders have been submitted by or on behalf of more than one person) groups of tenderers concerned will be given the opportunity of accepting a joint licence each tenderer or group of tenderers (as the case may be) contributing an equal share of the premium offered. If a proposal to award a joint licence shall not have been accepted by all such tenderers within 14 days of the date upon which notice of the proposal was given in manner hereinafter specified, the award of the licence will be at the discretion of the Secretary of State. The provisions of sub-paragraph (9) with regard to the address and the despatch of letters shall likewise apply to the communication of any proposal made pursuant to this sub-paragraph;
- (9) each successful tenderer shall be informed of the acceptance of his tender by the Secretary of State by letter sent by recorded delivery post to the tenderer at the address given in the tender. Any tenderer whose tender is not accepted will also be notified by post. The balance of the tender premium shall be payable within 14 days of the date upon which the letter of acceptance is posted. On the payment of such balance, a form of licence will be prepared by the Secretary of State for execution and completion (in duplicate) by the successful tenderer. In the event of the withdrawal of the successful tenderer or his failure to pay such balance by the due date, the deposit shall be forfeited and the award of a licence for the block or blocks concerned will be at the discretion of the Secretary of State.
