The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 1, 2 and 13 of the Import Duties Act 1958.

viz: The Import Duties (General) (No. 7) Order 1971.

This Order, which comes into operation on 1st January, 1972:

- (1) consolidates the Import Duties (General) (No. 7) Order 1970 and the Orders amending it,
- (2) completes the process begun by the Import Duties (General) (No. 4) Order 1968 and continued in subsequent Orders, in that it again reduces, as the fourth and last of a series of reductions, the full rate of import duty (and, where applicable the Commonwealth preference rate) on a wide range of goods in accordance with the undertakings given by the United Kingdom at Geneva and set out in the June 1967 Protocol to the General Agreement of Tariffs and Trade (the Kennedy Round; Cmnd. 3347),
- (3) effects some further simplifications of the tariff by again reducing the number of subdivisions in certain headings and entirely eliminating those in others where previously differing rates of duty have been brought to the same level as a result of the reductions referred to in (2) above,
- (4) imposes new duties, generally at the rate of 85 per cent of the full rates, on imports of certain cotton textiles (as defined in the Order) from countries in the Commonwealth Preference Area other than the Republic of Ireland,
- (5) provides in some descriptions and rates of duty for a change to metric units where consultation has shown their use to be desired by the industries concerned,
- (6) adapts the text of certain chapter notes and headings to take account of the consolidation of the law relating to the Hydrocarbon oil duty in the Hydrocarbon Oil (Customs and Excise) Act 1971,
- (7) effects minor alterations to the tariff, including modifications in certain headings to facilitate implementation of the provisions of section 1 of the Finance Act 1971 introducing the Generalised System of Preferences and
- (8) incorporates amendments to tariff headings, section and chapter notes and the interpretative rules to give effect to a Recommendation of the

Customs Co-operation Council designed to bring the Brussels Nomenclature (on which the United Kingdom Tariff is based) abreast of various technological developments and in other respects to improve its texts.

The Order comes into operation on 1st January, 1972, and has been published as Statutory Instrument 1971 No. 1813.

PUBLIC ORDER ACTS (NORTHERN IRELAND) 1951 to 1971

Whereas I, the Right Honourable Brian Faulkner, Minister of Home Affairs, am of the opinion in consequence of information furnished to me by the Chief Constable of the Royal Ulster Constabulary that by reason of the unrest and tension at present existing in Northern Ireland the holding of any public procession in any public highway, road, or street is likely to cause serious public disorder or to cause undue demands to be made upon the police or military forces.

Now, therefore, I, the Right Honourable Brian Faulkner, Minister of Home Affairs, in exercise of the powers conferred upon me by Section 2(2) of the Public Order Act (Northern Ireland) 1951 do hereby order that the holding of all public processions in any public highway, road or street in Northern Ireland is prohibited for the period commencing on 12th November, 1971, and ending on 8th February, 1972.

This Order revokes the Order made by me on 9th August, 1971.

URBAN DRAINAGE ACT (NORTHERN IRELAND) 1957

(CHARTER SECOND AMENDMENT) BILL (NORTHERN IRELAND)
