## State Intelligence

### H.M. TREASURY

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 1, 2 and 13 of the Import Duties Act 1958.

Viz: The Import Duties (General) (No. 8) Order 1971.

This Order reduces the full and E.F.T.A. rates of import duty on drained and glace cherries from twenty per cent to ten per cent ad valorem.

This Order comes into operation on 2nd December, 1971, and has been published as Statutory Instrument 1971 No. 1891.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 1 of the Finance Act 1971.

Viz.: The Import Duties (Developing Countries) Order 1971.

This Order, which comes into operation on 1st January, 1972:

(1) Implements until 1st January, 1973, the Generalised System of Tariff Preferences under which a wide range of goods imported into the United Kingdom from certain developing countries may be relieved wholly or in part from the duties normally chargeable under the Import Duties Act 1958, but not from duties chargeable under other enactments.

(2) Specifies the places from which goods must be consigned to the United Kingdom if, on importation, they are to be eligible for this relief from import duty.

Schedule 1 to the Order names the developing countries whose goods may be eligible for this relief and lists the approved ports of consignment for certain of those countries which require to consign their goods from ports in another country.

Schedule 2 sets out the United Kingdom Tariff headings and sub-headings under which goods are eligible for admission into the United Kingdom free of import duty; and

Schedule 3 sets out the tariff headings and sub-headings under which goods are eligible for admission at a reduced rates of import duty and states in each case the maximum rate of duty payable.

### SPECIAL ROADS ACT (NORTHERN IRELAND) 1963

#### BELFAST URBAN MOTORWAY

The Lord Mayor Aldermen and Citizens of the City of Belfast (hereinafter called "the Corporation") propose to construct the following connecting roads:

1. Approximately 430 yards of roads connecting the Belfast Urban Motorway on its eastern side with a new road being the new road extending for a distance of approximately 177 yards as hereinafter mentioned in paragraph (4) of part 3 (a) hereof.
2. Approximately 417 yards of road connecting York Street with the Belfast Urban Motorway on its western side.

All within the City and County Borough of Belfast.

In connection with the proposed construction of the connecting roads and in accordance with the provisions of Schedule 1 to the Special Roads Act (Northern Ireland) 1963, the Corporation hereby gives Notice that it has applied to the Ministry of Development for Northern Ireland for an Order under Sections 1, 2, 5, 7, 16 and 26 of the Act.

The general purposes of the intended Order will be:

1. To provide that the aforementioned connecting roads will be special roads.
2. To provide that the Corporation will be the special road authority for the aforementioned connecting roads.
3. To authorise the Corporation:
  - (a) to construct the following new lengths of public roads:
    - (1) A new road commencing from a point adjacent to the junction of York Street and Whitla Street and extending south for a distance of approximately 653 yards to join that section of Great George's Street to be altered and improved as hereinafter mentioned.
    - (2) A new road extending for a distance of approximately 97 yards and joining

Whitla Street with the new road described at paragraph (1).

- (3) Three new roads extending for distances of approximately 66, 77, and 23 yards respectively and joining York Street with the new road described at paragraph (1), two of the new roads situate in the area between Nile Street and Henry Street and the other in part of Fleet Street.
  - (4) Two new roads extending for distances of approximately 63 and 177 yards respectively and joining a part of Henry Street and a part of Earl Street to the new road described at paragraph (1).
  - (5) A new road extending for a distance of approximately 67 yards and joining York Street on its west side with Great George's Street.
- (b) to carry out the following alterations and improvements to a road:
- Great George's Street from a point approximately 43 yards west of its junction with Nelson Street and extending for a distance of 93 yards west to join York Street
- (c) to stop up wholly the following roads or parts of roads:
- (1) Henry Street from its junction with York Street for a distance of approximately 137 yards;
  - (2) Little York Street from its junction with Nile Street for a distance of approximately 81 yards to its junction with Great George's Street;
  - (3) Nile Street from its junction with Little York Street for a distance of approximately 41 yards;
  - (4) Stanley Lane;
  - (5) Stanley Place;
  - (6) Shipbuoy Street from its junction with Little York Street for a distance of approximately 37 yards;
  - (7) Garston Street.
4. To amend the Belfast Urban Motorway (Donegall Road to Whitla Street) Order (Northern Ireland) 1969 by providing that the lengths of road proposed to be constructed in pursuance of that Order and described in paragraphs 11 and 12 of Part 2 of the Schedule to that Order shall not be constructed and shall cease to be trunk roads and special roads.
  5. To provide that the connecting roads shall be trunk roads.
  6. To revoke paragraphs 11 and 12 of Part 2, so much of paragraph 51 of Part 4 as relates to Great George's Street from its junction with the west side of York Street for a distance of approximately 19 yards and paragraph 4 of Part 5 of the Schedule to the Belfast Urban Motorway (Donegall Road to Whitla Street) Order (Northern Ireland) 1969.
  7. To provide that the aforementioned connecting roads shall be used only by traffic of Classes I and II as described in Schedule 3 to the Special Roads Act (Northern Ireland) 1963.

The route of the proposed connecting roads, the location of the new roads which it is proposed to construct, the alterations and improvements to a road, the roads or parts of roads proposed to be stopped up, the lengths of road originally proposed to be constructed in pursuance of the Belfast Urban Motorway (Donegall Road to Whitla Street) Order (Northern Ireland) 1969 and not now proposed to be constructed and the aforementioned connecting roads which are proposed to be trunk roads are delineated on a map, a copy of which, together with a copy of the draft Order, may be inspected by any person free of charge at all reasonable hours during the period from 1st December, 1971, to 3rd January, 1972, at the Office of the Town Clerk, City Hall, Belfast.

Any person may, within the said period, object to the making of the Order by Notice to the Ministry of Development, Roads Division, Stormont, Belfast BT4 3SS.

### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

*To: All to whom it may concern*

Pursuant to section 275(5) of the Customs and Excise Act, 1952, and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, namely two radiotelephonic transceivers wireless telegraphy apparatus consisting of radiotelephonic apparatus capable of transmitting on frequencies between 26.1 and 29.7 megacycles per second or between 88 and 108 megacycles per second have been seized as liable to forfeiture upon the grounds that under section 7 of the Wireless Telegraphy Act 1967 and the Radiotelephonic Transmitters (Control of Manufacture and Importation) Order 1968 the importation of the said goods is prohibited save with the authority of the Minister of Posts and Telecommunications who gave no such authority in respect of these goods.

Whereby and by force of Section 44(b) of the Customs and Excise Act, 1952, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.

The Ministry of Commerce has made Regulations entitled the Weights and Measures (Weights) Regulations (Northern Ireland) 1971 (S.R.&O. 1971 No. 342) under Sections 5(1) and (3) and 8(1) of the Weights and Measures Act (Northern Ireland) 1967.

They make provision for the testing and passing of weights as fit for use for trade and the stamping by inspectors of weights and measures of weights so passed.
