H.M. TREASURY

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 3 of the Finance Act 1971 viz.: The Excise Duties (Gas as Road Fuel) Order 1972. This Order brings into force, with effect from 3rd July, 1972, Section 3 of the Finance Act 1971 which provides for the charge of excise duty on gas for use as fuel in road vehicles. This Order also provides that the rate of duty chargeable per liquid gallon shall be one-half of the rate of excise duty for the time being chargeable on hydrocarbon oil. This Order comes into operation on the 3rd July, 1972 and has been published as Statutory Instruments 1972 No. 567.

AGRICULTURAL MARKETING ACT (NORTHERN IRELAND) 1964

Marketing Act (Northern Ireland) 1964 as amended by Section 9 of the Agriculture (Miscellaneous Provisions) Act (Northern Ireland) 1970, the Ministry of Agriculture has made a Statutory Rule dated 27th March, 1972 entitled the Movement of Pigs Regulations (Northern Ireland) 1972 (S.R. & O. 1972, No. 90).

The Regulations, which come into operation on 1st May, 1972, provide that:

- (a) the movement of pigs from any land or premises may be restricted for a period not exceeding twenty-four hours by any person authorised in writing by the Pigs Marketing Board. or by any member of the Royal Ulster Constabulary;
- (b) where more than two bacon pigs are being transported the person in charge of the vehicle must be in possession of a document issued by the Board showing that they are in transit to one of the Board's purchasing centres, or else a movement permit issued by the Board;
- (c) authorised persons may halt vehicles carrying pigs; inspect documents; require the weighing of pigs being transported and information as to destination and ownership; seize and detain pigs being or suspected of having been moved in contravention of the Regulations, and any vehicle, container or thing in, or with which, they are, or are suspected of having been handled or carried;
- (d) where any vehicle transporting pigs is halted by an authorised person and found not to contain any pig being moved in contravention of the Regulations, any expenses reasonably incurred in complying with the provisions of the Regulations shall be defrayed by the Pigs Marketing Board.

Provision is also made for the publication of notice of seizure, for claims relating to pigs seized, and for the forfeiture of things seized.

AGRICULTURE (TEMPORARY ASSISTANCE) ACTS (NORTHERN IRELAND) 1954 AND 1957
