THE SPRUCEFIELD - NEWRY - LAND FRONTIER TRUNK ROAD

The Ministry of Development hereby gives Notice, in accordance with the provisions of the First Schedule to the Roads Act (Northern Ireland) 1948, that it proposes to make an Order under Sections 1 and 3 of the Act directing:

- that a length of approximately 2.6 miles of new road to be constructed in the townlands of Moneymore, Aughintober, Maddydrumbrist, Derrycraw, Corgary, Corcreeghy and Carnmeen in the County of Down and extending in a generally southerly direction from a point on the trunk road about 275 yards north of its junction with the Ballyblaugh Road (DR160) in the townland of Moneymore to a point on the trunk road about 225 yards south of Sheep Bridge in the townland of Carmeen shall become part of the trunk road (T4); and
- that two lengths of the existing trunk road together measuring about 1,100 linear yards

which will be superseded by parts of the abovementioned new road shall, from 1st April next after the date on which the new road is opened to through traffic, cease to be part of the trunk road.

The proposed Order will also authorise the Ministry:

- i. to improve the following junctions:
  - (a) the junction which will exist between the western side of the new road and the Four Mile House Road (DR147) in the townland of Aughintober;
  - (b) the two junctions which will exist between the existing trunk road and the western side of the new road in the townland of Derrycraw;
  - (c) the two junctions which will exist between the existing trunk road and the eastern side of the new road in the townland of Derrycraw;
  - (d) the junction which will exist between the existing trunk road, and the western side of the connecting road mentioned at ii(e) below the townland of Corcreeghy.
- ii. to construct the following connecting roads:
  - (a) two roads to provide better connections between part of the existing trunk road to be superseded and the eastern side of the new road in the townlands of Aughintober and Maddydrumbrist;
  - (b) a road to connect the Beechill First Division Road (DR161) to the western side of the new road in the townland of Derrycraw;
  - (c) a road to connect the Beechill Second Division Road (DR129) to the eastern side of the new road in the townland of Derrycraw;
  - (d) a road to connect the Poyntzpass to Newry Road (C337) to the western side of the new road in the townland of Corgary including an improvement of the junction between C337 and the Drumiller Road (DR168);
  - (e) a road to connect the Corcreeghy to Annaclone Road (C340) to the eastern side of the new road in the townland of Corcreeghy;
  - (f) a road to connect the Corcreeghy to Ardaragh Road (or Tormore Road) (C339) to the eastern side of the new road in the townland of Corcreeghy.
- iii. to stop up wholly the road junctions between:
  - (a) specified parts of the existing trunk road

- and the eastern side of the new road in the townlands of Aughintober, Maddydrumbrist, Corgary and Corcreeghy;
- (b) the eastern side of the new road and the Four Mile House Road (DR147) in the townland of Aughintober;
- (c) the western side of the new read and the Beechill First Division Road (DR161) in the townland of Derrycraw;
- (d) the castern side of the new road and the Beechill Second Division Road (DR129) in the townlands of Derrycraw and Maddydrumbrist:
- (e) the eastern side of the new road and the Corcreeghy to Ardaragh Road (or Tormore Road) (C339) in the townland of Corcreeghy; and
- (f) the western side of the new road and the Poyntzpass to Newry Road (C337) in the townland of Corgary.
