THE SOUTH EAST WALES PILOTAGE ORDER 1974

AERODROMES ACT (NORTHERN IRELAND) 1971

(as amended) of the Cereals Marketing Act 1965 for the imposition of a levy on wheat, barley and oats grown and sold in the United Kingdom to commence on a date within the period of 12 months beginning on 1st August, 1974. The Scheme proposes that growers and processors of, and dealers in, home-grown wheat, barley and oats will each bear part of the levy.
