### NORTHERN IRELAND OFFICE

Notice is hereby given that the Secretary of State, in pursuance of section 146 of the County Courts Act (Northern Ireland) 1959, on the recommendation of the County Court Rules Committee and after consultation with the Lord Chief Justice, has made a Statutory Rule entitled the County Court (Costs in Affiliation and Separation and Maintenance Appeals) (Amendment) Rules (Northern Ireland) 1974 (S.R. 1974, No. 110) which comes into operation on 1st August 1974.

These Rules increase from £21 to £30, the maximum figure for costs recoverable in respect of a solicitor's remuneration and outlay or for counsel's fee, respectively, to the County Court by a successful party from an unsuccessful party in an appeal from the order of a court of summary jurisdiction in affiliation or separation and maintenance proceedings.

Notice is hereby given that the Secretary of State in pursuance of section 23 of the Magistrates' Courts Act (Northern Ireland) 1964, on the recommendation of the Magistrates' Courts Rules Committee and after consultation with the Lord Chief Justice, has made a Statutory Rule entitled the Magistrates' Courts (Amendment) (No. 2) Rules (Northern Ireland) 1974 (S.R. 1974, No. 112), which will come into operation on 1st August, 1974.

These Rules amend the Magistrates' Court Rules (Northern Ireland) 1965 to provide for service of a copy of a maintenance or affiliation order and other orders for periodical payment on the defendant.

The Rules are also amended to require that, where on appeal by way of Case stated the Court of Appeal makes a direction for the continuance of a hearing by a Magistrates' Court, the parties shall be notified of the direction.

The Forms in Schedule 1 to those Rules are also amended by adding new Forms in relation to an offence committed during the operational period of a suspended sentence of imprisonment imposed by the County Court on appeal from a Magistrates' Court.

A new Form is substituted for the form of warrant to enforce an order by a County Court made on Appeal and by the Court of Appeal by way of Case stated.

## DEPARTMENT OF TRADE AND INDUSTRY

#### NEW REFERENCE TO THE MONOPOLIES AND MERGERS COMMISSION

Mr. Alan Williams, M.P., Minister of State for Prices and Consumer Protection, has asked the Monopolies and Mergers Commission to investigate and report on the supply of frozen foodstuffs in the United Kingdom.

The reference was made on 11th June, 1974, and is reproduced below. Any person or organisation wishing to offer evidence in relation to the reference should write to the Secretary, Monopolies and Mergers Commission, New Court, 48 Carey Street, London WC2A 2JT.

#### FAIR TRADING ACT 1973

#### Reference to the Monopolies and Mergers Commission Frozen Foods

The Secretary of State pursuant to section 51(1) of the Fair Trading Act 1973 hereby refers to the Monopolies and Mergers Commission the matter of the existence or possible existence of a monopoly situation in the supply in the United Kingdom of frozen foodstuffs for human consumption.

The Monopolies and Mergers Commission shall upon this reference investigate and report on the questions whether a monopoly situation exists, and, if so:

- (a) by virtue of which provisions of sections 6 to 8 of that Act that monopoly situation is to be taken to exist;
- (b) in favour of what person or persons that monopoly situation exists;
- (c) whether any steps (by way of uncompetitive practices or otherwise) are being taken by that person or those persons for the purpose of exploiting or maintaining the monopoly situation and, if so, by what uncompetitive practices or in what other way; and
- (d) whether any action or omission on the part of that person or those persons is attributable to the existence of the monopoly situation and, if so, what action or omission and in what way it is so attributable; and
- (e) whether any facts found by the Commission in pursuance of those investigations operate, or may be expected to operate, against the public interest.

In this reference:

"frozen foodstuffs" means prepacked foodstuffs preserved by freezing other than -

- (i) whole animals or birds (whether prepared for cooking or not);
- (ii) uncooked butchers' meat;

(iii) ice cream and water ices;

"butchers' meat" means any part of an animal of any of the following descriptions namely, cattle, sheep and swine but does not include chopped or minced meat or products containing such meat or meat which has been dipped or stuffed or similarly prepared for cooking;

"prepacked" means made up in advance in a container ready for retail sale in a frozen condition in that container or made up in advance in a container for retail sale loose in a frozen condition; and

"retail sale" includes sale to persons purchasing in the course of a catering business.

The Commission shall report on this reference within a period of two years from the date hereof.
