NORTHERN IRELAND OFFICE

Notice is hereby given that the Secretary of State in pursuance of Section 36(1)(a) of the Coroners Act (Northern Ireland) 1959, read with Section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962, has made a Statutory Rule entitled the Coroners (Salaries) Rules (Northern Ireland) 1974 (S.R. 1974, No. 115) which shall come into operation on 15th July, 1974, having effect from 30th June, 1974.

These Rules increase the salary rates for Coroners and Deputy Coroners in Northern Ireland and the Coroner's Officer for Belfast.

Notice is hereby given that the Secretary of State, in pursuance of section 146 of the County Courts Act (Northern Ireland) 1959, upon the recommendation of the County Court Rules Committee and after consultation with the Lord Chief Justice, has made a Statutory Rule entitled the County Court (Adoption) (Amendment) Rules (Northern Ireland) 1974 (S.R. 1974, No. 111) which comes into operation on 1st August, 1974.

These Rules amend the County Court (Adoption) Rules (Northern Ireland) 1969.

The amendments take account of the Health and Personal Social Services (Northern Ireland) Order 1972 (S.I. 1972/1265 (N.I. 14)) and the Departments (Transfer of Functions) Order (Northern Ireland) 1973 (S.R.&O. 1973, No. 504) whereby the functions of the Ministry of Home Affairs became those of the Department of Health and Social Services. The functions of the latter are, in consequence of directions made by the Ministry of Home Affairs, under Article 17 of the 1972 Order dated 24th September, 1973 (referred to in the Belfast Gazette dated 28th September, 1973, on page 635), now discharged by Health and Social Services Boards. Under Article 9(3) of the 1973 Order those directions are continued in force as if they had been duly made by the Department of Health and Social Services.

The Rules also amend the prescribed Forms of Adoption Order to take into account the coming into operation of the Births, Deaths and Marriages Registration (Northern Ireland) Order 1973 (S.I. 1973/600 (N.I. 8)).

Notice is hereby given that the Secretary of State, in pursuance of section 111 of the Legal Aid and Advice Act (Northern Ireland) 1965, has made a Statutory Rule entitled the Legal Aid (General) (Amendment) Regulations (Northern Ireland) 1974 (S.R. 1974, No. 126) which comes into operation on 1st August, 1974.

These Regulations amend the Legal Aid (General) Regulations (Northern Ireland) 1965.

The Regulations, amongst other matters, contain provision as to the period for which an emergency certificate is to remain in force and for the extension, in certain circumstances, of the certificate.

The regulation relating to the discharge of civil aid certificates is amended and provision is made for the suspension, in certain circumstances, of the certificate.

The circumstances in which the Secretary may perform functions on behalf of the Legal Aid Committee or a certifying committee are extended.

The Law Society is authorised to take proceedings to enforce an order or agreement for the recovery or preservation of property for the benefit of, or the payment of costs to, an assisted person, notwithstanding that the assisted person may be in a position to do so himself.
