DEPARTMENT OF COMMERCE

Notice is hereby given that the Department of Commerce has made regulations entitled the Insurance Companies (Intermediaries) Regulations (Northern Ireland) 1974 (S.R. 1974, No. 250).

The regulations relate to the issue of invitations to enter into ordinary long-term insurance policies (other than by way of reinsurance) with insurance poncies (other init by Kingdom who are not authorised to carry on ordinary long-term insurance business in the United Kingdom. Ordinary long-term insurance business includes life in-surance business. If the person who issues the invitation is connected with the insurer he must give the person to whom the invitation is issued a written statement of the facts giving rise to that connection. If the person who issues the invitation does so in the course of carrying on any business or profession he must give the person to whom the invitation is issued a written statement that the insurer is not authorised to carry on ordinary long-term insurance business in the United Kingdom.

Notice is hereby given that the Department of Commerce has made Regulations entitled the Insurance Companies (Contents of Advertisements) Regulations (Northern Ire-land) 1974 (S.R. 1974, No. 251).

The regulations prescribe the contents of advertisements of any kind which offer ordinary long-term insurance policies (other than by way of re-insurance) by an insurer from outside the United Kingdom who is not authorised to carry on ordinary long-term insurance business, which includes life insurance business, in the United Kingdom. Such advertisements must state that the insurer is not so authorised. If the name of the intermediary in the United Kingdom who acts for the insurer is stated and the intermediary and the insurer are not independent of each other, the advertisement must state that fact.

Where the authorised capital of the insurer is stated in any insurance advertisement the amount of the subscribed capital and the amount of the capital which has been paid up must also be stated.

THE IMPORTED FOOD (NORTHERN IRELAND) REGULATIONS 1968

United States of America: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby recognises, subject to the conditions hereinafter set out, the Official Certificates of which particulars are given in the Schedule hereto as showing:



- circumstances conton any other occasion been used

- (ii) Where the Official Certificates are in the form of stamps, the recognition will apply only if the stamps are clearly impressed or otherwise marked on the meat or the meat product or the package containing the meat or the meat product.
- (iii) Recognition of the Official Certificate is restricted to those completed by the insertion of one of the establishment numbers currently approved by the Minister of Agriculture, Fisherics and Food.

Summary of Return of Outbreaks of Diseases which have been Confirmed by or Reported to the Department
