**THE OFFSHORE INSTALLATIONS (CONSTRUCTION AND SURVEY) REGULATIONS 1974**

In exercise of his powers under the above-named Act and Regulations, the Secretary of State for Energy has appointed the Halcrow, Ewbank and Associates Certification Group as a Certifying Authority for offshore installations.
