THE IMPORTED FOOD (NORTHERN IRELAND)

REGULATIONS 1968

France: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food, gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby restricts recognition of the Official Certificate reproduced in the First Schedule to the Notice published in the Belfast Gazette dated 10th May, 1974, for the importation of poultry meat into Northern Ireland from France, to the extent shown in the Schedule hereto.

The Schedule to the Notice published in the Belfast Gazette dated 28th January, 1977, is hereby revoked.

NOTE:

Imports of meat and meat products (including poultry meat) into Northern Ireland are restricted or prohibited under Diseases of Animals legislation by the Department of Agriculture and applications for such importations must be made to that Department. Official Certificates for public health purposes in accordance with the Imported Food (Northern Ireland) Regulations, 1968, do not confer any exemption from these restrictions or prohibitions.

Netherlands: Official Certificate

The Department of Health and Social Services, with the approval of the Minister of Agriculture, Fisheries and Food, gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby restricts recognition of (1) the Official Certificates reproduced in the Schedules to the Notice published in the Belfast Gazette dated 8th April, 1938, and in the London Gazette dated 19th January, 1965, for the importation from the Netherlands of meat products and bacon and (2) the Official Certificate reproduced in the Schedule to the Notice published in the Belfast Gazette dated 31st August, 1973, for the importation into Northern Ireland from the Netherlands of meat (including bacon), to the extent shown in the Schedule hereto.

The Notice published in the Belfast Gazette dated 14th January, 1977, is hereby revoked.
