#### NOTE:

*Imports of meat and meat products (including poultry meat) into Northern Ireland are restricted or prohibited under Diseases of Animals legislation by the Department of Agriculture and applications for such importations must be made to that Department. Official Certificates for public health purposes in accordance with the Imported Food (Northern Ireland) Regulations, 1968, do not confer any exemption from these restrictions or prohibitions.*

## DEPARTMENT OF THE ENVIRONMENT

Notice is hereby given that the Department of the Environment in exercise of the powers conferred by Section 44(1) of the Road Traffic Act (Northern Ireland) 1970 and of all other enabling powers made an Order dated 28th April, 1977, entitled the Roads (Temporary Speed Limit) Order (Northern Ireland) 1977 (S.R. 1977 No. 111).

This Order has the effect of reimposing the maximum speed limit of 70 m.p.h. on motorways, raising from 60 m.p.h. to 70 m.p.h. the maximum speed limit on dual carriageways which are not motorways and raising from 50 m.p.h. to 60 m.p.h. the maximum speed limit or any other road from midnight on Tuesday, 31st May, 1977, for a period of 4 months ending at midnight on 30th September, 1977.

By virtue of Section 44(2) of the Road Traffic Act (Northern Ireland) 1970 this Order does not operate to increase any maximum speed limit imposed under any other enactment with respect to roads, motor vehicles or the drivers of motor vehicles.
