

Allowances (Pupils Over Compulsory School Age) (Amendment) Regulations (Northern Ireland) 1977. (S.R. 1977 No. 251.)

The purpose of this Rule is to introduce improved rates of maintenance allowances in respect of pupils over compulsory school age following full-time courses at grant-aided schools or institutions of further education. The Regulations also enlarge the amount which, in the calculation of those allowances, may be set against parental income in respect of dependants.

THE IMPORTED FOOD (NORTHERN IRELAND) REGULATIONS 1968

Federal Republic of Germany: Official Certificate

Imports of meat and meat products (including poultry meat) into Northern Ireland are restricted or prohibited under Diseases of Animals legislation by the Department of Agriculture and applications for such importations must be made to that Department. Official Certificates for public health purposes in accordance with the Imported Food (Northern Ireland) Regulations, 1968, do not confer any exemption from these restrictions or prohibitions.

Belgium: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 it hereby restricts recognition of (1) the Official Certificate reproduced in the Schedule to the Notice published in the Belfast Gazette dated 2nd July, 1971, for the importation from Belgium of meat products and bacon and (2) the Official Certificates reproduced in the Schedules to the Notices published in the Belfast Gazette dated 14th September, 1973, and 25th January, 1974, for the importation into Northern Ireland from Belgium of meat (including bacon), to the extent shown in the Schedule hereto.

The Notice published in the Belfast Gazette dated 29th July, 1977, is hereby revoked.
