NORTHERN IRELAND ORDERS IN COUNCIL

The following Orders have been made and are now available at Her Majesty's Stationery Office.

The Electricity Service (Finance) (Northern Ireland) Order 1977 No. 2154 (N.I. 25). Price 15p.

This Order reduces the liability of the Northern Ireland Electricity Service to the Department of Finance, and authorises the Department of Commerce to make certain contributions to the revenue account of the N.I.E.S.

The Agricultural Wages (Regulation) (Northern Ireland) Order 1977 No. 2151 (N.I. 22). Price 25p.

This Order consolidates the Agricultural Wages (Regulation) Acts (Northern Ireland) 1939 and 1940, and certain related enactments.

The Road Races (Northern Ireland) Order 1977 No. 2155 (N.I. 26). Price 25p.

This Order consolidates the Road Races Act (Northern Ireland) Order 1977 No. 2155 (N.I. 26). Price 25p.

This Order consolidates the Road Races Act (Northern Ireland) 1950 and related enactments.

The Development of Tourist Traffic (Northern Ireland) Order 1977 No. 2153 (N.I. 24). Price 15p.

This Order provides for the registration of, and payment of financial assistance to self catering establishments and extends the provision of financial assistance to certain catering establishments enabling assistance to be given in connection with the repair, replacement and redecorating of premises, furnishing and fittings. It also enables salaries to be paid to members of the Northern Ireland Tourist Board.

The Appropriation (No. 3) (Northern Ireland) Order 1977 No. 2152 (N.I. 23). Price 15p.

This Order authorises the issue of a further sum out of the Consolidated Fund of Northern Ireland for the service of the year ending on 31st March 1978, and appropriates that sum for specified services in Northern Ireland, It also authorises the application of certain further sums as appropriations in aid and reduces three sums already authorised to be applied as appropriations in aid. This Order consolidates the Rates (Northern Ireland) Order 1972 and the provisions amending it.

The Supplementary Benefits (Northern Ireland) Order 1977 No. 2156 (N.I. 27). Price 75p.

This Order consolidates the Supplementary Benefits Acts (Northern Ireland) 1966 to 1975 and related enactments.

The Supplementary Benefits etc. (Consequential Provisions) (Northern Ireland) Order 1977 No. 2158. Price 15p.

This Order makes consequential amendments in the Maintenance Orders Act 1950 and the Income and Corporation Taxes Act 1970 to take account of the consolidation of the legislation relating to supplementary benefits in Northern Ireland, and in the case of the Act of 1950, certain other changes in Northern Ireland statute law.

REDEMPTION AND CONVERSION OF 8½% ULSTER DEVELOPMENT BONDS
