##### FIRST-AID.

NOTICE is hereby given that the Ministry of Labour for Northern Ireland made an Order on the 8th May, 1928, prescribing that all materials for dressings contained in the First-Aid Boxes or cupboards which are required to be provided in pursuance of Section 26 (1) of the Workmen's Compensation Act (Northern Ireland), 1923, or Regulation 4 (a) of the Docks Regulations (N.I.), 1926, or Regulation 47 of the Buildings Regulations (N.I.), 1926, shall be thus designated in, and of a grade or quality not lower than the standards prescribed by the British Pharmaceutical Codex, 1923.
