The Civil Service Commissioners for Northern Ireland hereby give Notice that the following Regulations are published with the approval of the Ministry of Finance for Northern Ireland and with the concurrence of the Ministry of Home Affairs for Northern Ireland, viz. :—

REGULATIONS, dated the 11th July, 1928, respecting a Limited Qualifying Examination for the situation of **CLERK-TYPIST (Female)** in the County Court Service.

1. No candidate will be eligible who has not rendered at least six months' whole-time approved service prior to the 9th June, 1925 (being the date on which the County Officers and Courts Act (Northern Ireland), 1925, came into operation) as a Clerical or Typing Assistant in the employment of a Clerk of the Crown and Peace on duties appropriate to the County Court Service or to the functions exercised by the Clerk of the Crown and Peace as Local Registering Authority, and has not continued on and from the 9th June, 1925, to render such whole-time approved service up to the date of these Regulations.
