

DEPARTMENT OF THE ENVIRONMENT

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Section 89 of the Road Traffic Act (Northern Ireland) 1970 and of all other enabling powers made on 10th May, 1979, Bye-Laws entitled the Off-Street Parking (Amendment) (No. 2) Bye-Laws (Northern Ireland) 1979 (S.R. 1979 No. 168).

The effect of the Bye-Laws is to control the use of certain off-street car parks in the towns of Magherafelt and Larne.

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Section 19 of the Road Traffic Act (Northern Ireland) 1970 and of all other enabling powers made on 10th May, 1979, an Order entitled the One-Way Traffic (Strangford) Order (Northern Ireland) 1979 (S.R. 1979 No. 169) which will come into operation on 18th June, 1979.

This Order gives legal effect to a one-way traffic system in Strangford.

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by article 3(2) of the Roads and Road Traffic (Northern Ireland) Order 1978 and of all other enabling powers made on 14th May, 1979, regulations entitled the Roads (Control of Builders' Skips) (Amendment) Regulations (Northern Ireland) 1979 (S.R. 1979 No. 173) which will come into operation on 4th June, 1979.

These Regulations revoke articles 3 and 4 of the Roads (Control of Builders' Skips) Regulations (Northern Ireland) 1979 (S.R. 1979 No. 85).

The purpose of this amendment is to remove from the regulations a restriction relating to the depositing of a skip in such a position as to cause or to be likely to cause any obstruction or danger. Such depositing of skips is already an offence under Part II of the Order. It also removes the authority purportedly conferred on the Department to authorise the depositing of skips in certain circumstances.

GAME PRESERVATION ACT (NORTHERN IRELAND) 1908

GAME LAW AMENDMENT ACT (NORTHERN IRELAND) 1951

Notice is hereby given that the Department proposes to make an Order under the above-mentioned Acts:

- prohibiting the sale or purchase of grouse for consumption in Northern Ireland or elsewhere at any time from 11th August, 1979, to 11th August, 1980.
- prohibiting the shooting or taking of partridge at any time from 30th September, 1979, to 30th September, 1980;
- prohibiting the killing of hen pheasants at any time from 30th September, 1979, to 30th September, 1980, except where exemption is granted by the Department;
- 4. prohibiting the sale or purchase of hen pheasants for consumption in Northern Ireland or elsewhere at any time from 30th September, 1979, to 30th September, 1980, except hen pheasants killed by a person exempted under paragraph 3, which may be sold to a licensed game dealer.

Any person objecting to any of these proposals should do so in writing to the Department at Stormont, Belfast BT4 3SS, not later than 22nd June, 1979.

WAGES COUNCILS ACT (NORTHERN IRELAND) 1945
Boot and Shoe Repairing Wages Council (Northern Ireland)

The Boot and Shoe Repairing Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Department of Manpower Services proposals for fixing statutory minimum remuneration in substitution for the statutory minimum remuneration fixed by the current wages regulation orders relating to workers in respect of whom the Wages Council operates.

The Wages Council will consider any written representations with respect to the above-mentioned proposals which may be sent to it within twenty-one days from 1st June, 1979.
