The exceptions are concerned with various types of work, licences, certificates permits, and proceedings. Exceptions are also made in relation to action taken for the purpose of safeguarding national security or of protecting public safety or public order.

- (e) give the Department additional powers of control over the names of companies;
- (f) amend the law relating to the delivery of certain documents to the registrar of companies;
- (g) otherwise amend the Companies Act (Northern Ireland) 1960.

### STATUTORY RULES OF NORTHERN IRELAND 1979 No. 200

### ROAD TRAFFIC AND VEHICLES

Restriction of Traffic (Yukon Street and Severn Street, Belfast) Order (Northern Ireland) 1979

Made

12th June 1979

Coming into operation

7th July 1979

The Department of the Environment being satisfied that traffic on the lengths of road described in the schedule should by reason of works being executed be restricted and having regard to the existence of alternative routes suitable for the traffic which will be affected and after giving public notice of its intention in exercise of the powers conferred by section 22 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and of every other power enabling it in that behalf hereby makes the following order:

#### Citation and commencement

 This order may be cited as the Restriction of Traffic (Yukon Street and Severn Street, Belfast) Order (Northern Ireland) 1979 and shall come into operation on 7th July, 1979.

#### **Prohibition**

 Subject to article 3 the use of the lengths of road described in the schedule by vehicles is prohibited for a period of 4 months commencing on 8th July, 1979.

### **Exemptions**

- 3. Article 2 shall not apply to vehicles:
  - (a) engaged in the works being executed; or
  - (b) requiring access to premises or lands abutting on said lengths of road.

### SCHEDULE

- A length of approximately 10 metres of Yukon Street, Belfast, extending in a northerly direction from its junction with Severn Street.
- A length of approximately 15 metres of Severn Street, Belfast, extending in an easterly direction from its junction with Yukon Street.

### EXPLANATORY NOTE

(This note is not part of the order but is intended to indicate its general purport.)

The effect of the order is to prohibit the use of a length of approximately 10 metres of Yukon Street, Belfast, extending in a northerly direction from its junction with Severn Street, and a length of approximately 15 metres of Severn Street, Belfast, extending in an easterly direction from its junction with Yukon Street for a period of 4 months commencing on 8th July, 1979, by all vehicles in order for road works to be executed.

Provision is made to exempt vehicles engaged in the works also to exempt vehicles requiring access to premises abutting on the road.

Traffic signs indicating the effect of the order have been erected on the road.

Any person who acts in contravention of the order is liable on summary conviction to a fine not exceeding £50.

The Department of the Environment being satisfied that traffic on the length of road described in article 3 should by reason of works being executed be restricted and having regard to the existence of alternative routes suitable for the traffic which will be affected and after giving public notice of its intention in exercise of the powers conferred by section 22 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and of every other power enabling it in that behalf hereby makes the following order:

#### Citation and commencement

 This order may be cited as the Restriction of Traffic (King's Road, Belfast) Order (Northern Ireland) 1979 and shall come into operation 15th July, 1979.

#### Revocation

2. The Restriction of Traffic (King's Road, Belfast) Order (Northern Ireland) 1978(c) is hereby revoked.

#### Prohibition

 Subject to article 4 the use of King's Road, Belfast, from its junction with Knock Road to its junction with Gilnahirk Road by vehicles proceeding in a north-westerly direction is prohibited for a period of 8 months commencing on 16th July, 1979.

- Article 3 shall not apply to vehicles engaged in the works being executed.

### EXPLANATORY NOTE

(This note is not part of the order but is intended to indicate its general purport.)

The general effect of the order is to restrict the use of King's Road, Belfast, from its junction with Knock Road to its junction with Gilnahirk Road by vehicles proceeding in a north-westerly direction for a period of 8 months commencing on 16th July, 1979, in order for road works to be executed.

This shortens the length of road shown in the Restriction of Traffic (King's Road, Belfast) Order (Northern Ireland) 1978 (S.R. 1978 No. 381) which has now been revoked.

Traffic signs indicating the effect of the order have been erected on the roads.

Any person who acts in contravention of the order is liable on summary conviction to a fine not exceeding £50.

They provide that medical examinations of persons employed and related functions under the instruments in the Table below shall be performed by fully registered medical practitioners appointed in accordance with the provisions of the said Order.

They also change the procedure by which the employment of any person in certain processes mentioned in the said instruments may be prohibited where the doctor examining that person is of the opinion that the continued employment of that person in that process would involve special danger to his health.
