NATIONAL HEALTH INSURANCE ACTS,
1924 and 1926.

AND THE NATIONAL HEALTH
INSURANCE ACT (NORTHERN IRE-
LAND), 1926.

NOTICE is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, with the consent of the Treasury and the Ministry of Finance for Northern Ireland, after the expiration of at least 40 days from this date, in exercise of the powers conferred upon them by the National Health Insurance Acts, 1924 and 1926, and the National Health Insurance Act (Northern Ireland), 1926, to make Regulations for amending the National Health Insurance (Approved Societies) Regulations, 1924, and the National Health Insurance (Approved Societies) Amendment Regulations, 1927;

And that on account of urgency the National Health Insurance Joint Committee under section 2 of the Rules Publication Act, 1893, made regulations entitled the National Health Insurance (Approved Societies) Amendment Regulations (No. 2), 1928, to come into force immediately as provisional regulations to continue in force until regulations have been made in accordance with the provisions of section 1 of that Act;

GAME.

MEMORANDUM of an Agreement made the 24th day of August, 1928, under Section 3 of the Finance Act (Northern Ireland), 1928, between the Ministry of Finance for Northern Ireland (hereinafter called the Ministry) and the Ministry of Home Affairs for Northern Ireland for the exercise by officers and constables of the Royal Ulster Constabulary of certain powers with respect to Game Certificates and Licences and Gun Licences.

(1) Officers and constables of the Royal Ulster Constabulary shall exercise and perform in Northern Ireland the powers of the Ministry with respect to the granting, signing, and issue of Gun Licences and Game Certificates and Licences other than Licences to deal in game.

(2) Officers and constables of the Royal Ulster Constabulary shall exercise the powers of an officer of the Ministry with respect to the discovery and prosecution of offences against the Acts relating to Excise Duty chargeable on
