MINERAL DEVELOPMENT ACT (NORTHERN IRELAND) 1969

The Department of Commerce (hereinafter referred to as "the Department") hereby gives notice pursuant to section 11(3) of the above Act that the Department proposes in exercise of its powers under section 11 of the above Act to grant a prospecting licence authorising Rio Tinto Finance & Exploration Limited to enter the lands in the Counties of Londonderry and Tyrone listed in the Schedule hereto and there do all such things as are necessary for or reasonably incidental to the purposes of searching for all such mines and minerals as are vested in the Department.

WEIGHTS AND MEASURES ACT (NORTHERN IRELAND) 1967

The Department has made an Order which comes into force on 1st January, 1980, entitled:

"WEIGHTS AND MEASURES (COFFEE EXTRACTS AND CHICORY EXTRACTS) ORDER (NORTHERN IRELAND) 1979 (S.R. 1979 No. 384)

under the Weights and Measures Act (Northern Ireland) 1967.

The products covered by the Order are:

- (i) "solid and paste products" i.e. instant coffee, instant chicory, coffee extract paste, chicory extract paste and blends thereof;
- (ii) "liquid products" i.e. liquid coffee extracts, liquid chicory extracts, and blends thereof.

The principal requirements of the Order are:

- (a) solid and paste products which are not pre-packed shall, when sold by retail, be sold only by net weight;
- (b) solid and paste products weighing more than 25g (approximately 0.9 oz) and not more than 10 kg (approximately 22 lbs) are to be pre-packed only in prescribed imperial and metric weights;
- (c) where solid and paste products are made up in containers they must be marked with net weight (in quantities of 5 kg) (approximately 11 lbs) or more, not sold by retail, the net weight may be stated in an accompanying document);
- (d) liquid products, if pre-packed, must be marked with quantity by volume or capacity measurement;
- (e) where a container encloses packs which are not in themselves intended for individual sale, the container must also be marked with the total number of packs;
- (f) where identical containers are enclosed in an outer container, the outer container must be marked with the total number of inner containers and their net weight, unless the net weight of at least one of the inner containers and their total number can be seen from outside;
- (g) section 16 of the Act (relating to offences) is modified to take account of the case where information required by the Order may be given in an accompanying document.

This Order supersedes Part VIII and XI of Schedule 2 to the Weights and Measures Act (Northern Ireland) 1967 which will cease to have effect as respects the products covered.
