Notice is hereby given that the Department of Health and Social Services in exercise of the powers conferred on it by Section 4 and 68 of the Food and Drugs Act (Northern Ireland) 1958 has made regulations entitled Lead in Food Regulations (Northern Ireland) 1979. (S.R. 1979 No. 407)

These regulations which come into operation on 12th April, 1980, amend and supersede the Lead in Food Regulations (Northern Ireland) 1961, as amended.

The principal effects of these regulations will be to:

- a. reduce the permitted general limit of the content of lead in food from 2.0mg/kg to 1.0mg/kg;
- b. revise the list of specified foods and reduce in almost all, cases the individual limits applicable to those foods;
- c. reduce the limit for four groups of specified foods (certain fruit and vegetable juices, flavourings, apples and pears) in two years time;
- d. reduce the limit applicable to foods specially prepared for infants or young children from 0.5mg/kg to 0.2mg/kg; those sold in a dried, dehydrated or concentrated form will be subject to the new general limit of 1.0mg/kg which will, in general, when diluted or reconstituted equate to 0.2mg/kg;
- (e) introduce specific limits of 2.0mg/kg for fish and 10.00mg/kg for shellfish. Hitherto, lead naturally present in fish, at whatever level, has been permitted by the regulations.
