MISUSE OF DRUGS ACT 1971—SECTIONS 13 AND 14

Direction Prohibiting Exercise of Powers in Relation to Controlled Drugs

Notice is hereby given, in accordance with Section 16(2) of the Misuse of Drugs Act 1971, that the Secretary of State has given the following direction, which came into effect on 28th July, 1980:

The Secretary of State, in pursuance of Subsection (1) and also of Subsection (2) of Section 13 of the Misuse of Drugs Act 1971 and in accordance with Section 14 of that Act, by this Direction, prohibits Dr. Edward Charles Sugden MRCS, LRCP, MB, BChir, MRCOG, a doctor within the meaning of the Act, whose registered address is 4 Half Moon Street, London W1, from prescribing, administering and supplying and from authorising the administration and supply of any controlled drug within the meaning of that Act.

This Direction does not extend to the doing of anything in circumstances in which it may lawfully be done without being a doctor.

NORTHERN IRELAND OFFICE

- (2) They amend Order 42, rule 15, by increasing the rate of interest on judgments or orders for the recovery of money from 12½ per cent to 15 per cent per annum.

The Rule replaces, with amendments, the Students Awards Regulations (Northern Ireland) 1979. It sets out the amounts, terms and conditions of awards and comes into operation on 1st September, 1980.

Australia: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 as amended by the Imported Food (Northern Ireland) (Amendment) Regulations 1973 and 1979 it hereby recognises, subject to the conditions hereinafter set out, the Official Certificates of which particulars are given in Part I of the Schedule hereto as showing:

- that the meat to which they relate or the meat from which the meat product to which they relate was prepared, was derived from animals inspected before and after death and passed in accordance with criteria satisfactory to the Minister, and
- that the dressing, other preparation and packing of the meat or the meat product were carried out with all necessary precautions for the prevention of danger to health.

1. Recognition of the Official Certificate is extended to include:

- (a) boneless meat from which pleura or peritoneum has been removed, irrespective whether or not that removal was essential to the deboning process;
- (b) boneless meat from which any lymphatic gland has been removed in preparing or trimming the meat;
- (c) portions of carcasses, with or without bone, comprising recognisable wholesale or retail cuts which contain no associated lymphatic gland or from which has been removed, in preparing or trimming the meat, any pleura, peritoneum or lymphatic gland;
- (d) the tongue of any bovine animal from which has been removed any lymphatic gland in the preparation or trimming of the tongue;
- (e) i. portions of meat not exceeding three in any one package used to make up to a standard weight any package of boneless meat consisting substantially of one piece of meat provided that each such portion of meat is of such shape and in such condition as to afford sufficient means of identification with a definite part of the carcass; or
ii. portions of meat packed in the same package as recognisable cuts of meat each of such portions being at least eight cubic inches in volume provided that each such portion shall be in such a shape and such a condition as to afford sufficient means of identification with a definite part of the carcass.

Recognition does not extend to boneless veal appearing to an authorised officer to be from calves less than three months old.

2. The said certificates are recognised subject to the following conditions:

- (a) This recognition applies to the importation of meat and meat products from Australia.
- (b) Where the Official Certificates are in the form of labels, the recognition will apply only if the labels are securely affixed to the meat or the meat product and the package containing the meat or meat product, and if the labels have not in any other circumstances or on any other occasion been used as Official Certificates.
- (c) Where the Official Certificates are in the form of stamps, the recognition will apply only if the

stamps are clearly impressed or otherwise marked on the meat or the meat product and the package containing the meat or the meat product.

- (d) Recognition of the Official Certificate is restricted to the extent indicated in Part II of the Schedule hereto.

The Notices published in the London Gazette dated 5th November, 1965, and in the Belfast Gazette dated 2nd August, 1968, 4th December, 1970, and 19th August, 1977, are hereby revoked.
