BUILDING REGULATIONS (NORTHERN IRELAND) ORDER 1979

Notice is hereby given that the Department of Finance in exercise of the powers conferred on it by Article 1(2) of the Building Regulations (Northern Ireland) Order 1979 has made a Statutory Rule entitled Building Regulations (1979 Order) (Commencement No. 1) Order (Northern Ireland) 1980 (SR 1980 No. 331 (C9)). This Order brings into operation on 1st November, 1980 certain provisions of the Building Regulations (Northern Ireland) Order 1979 which consolidates the Building Regulations (Northern Ireland) Order 1972 as amended by the Building Regulations (Northern Ireland) Order 1978 and other enactments. The provisions being brought into operation include those contained in the 1972 Order and those of the 1978 Order which are currently in operation (ie to the extent that they were commenced by the Building Regulations (1978 Order) (Commencement No. 1) Order (Northern Ireland) 1979. The 1972 and 1978 Orders will at the same time be repealed.

Additionally some provisions of the 1972 Order which were amended by the 1978 Order and some new provisions included in the 1978 Order are now being brought into operation for the first time.

The principal additional provisions now being brought into operation are:

- Article 2(3) which defines the meaning of "building".
- Article 11(1) (b) which alters the powers of entry and inspection of an authorised officer.
- Article 17(2) which enables the period after which plans may be deemed to have been rejected to be extended.
- Article 17(6) to (8) which gives guidance on the determination of any question of law arising in connection with an appeal under that Article.
- Article 21 which raises the maximum penalties for contravention or failure to comply with building regulations and for wilful obstruction of an authorised officer.

- (b) revise the prescribed period for appeal against the rejection of plans.

DEPARTMENT OF COMMERCE

DEPARTMENT OF HEALTH AND SOCIAL SERVICES

THE IMPORTED FOOD (NORTHERN IRELAND) REGULATIONS 1968

South West Africa/Namibia: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales gives notice that in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 as amended by the Imported Food (Northern Ireland) (Amendment) Regulations 1973 and 1979 it hereby recognises, subject to the conditions hereinafter set out, the Official Certificate of which particulars are given in the Schedule hereto as showing:

- (a) that the meat to which it relates, or the meat from which the meat product to which it relates was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Minister, and
- (b) that the dressing, packing and other preparation of the meat or the meat product was carried out with all necessary precautions for the prevention of danger to health.

1. Recognition of the Official Certificate is extended to include:

Portions of carcasses, with or without bone, which contain no associated lymphatic gland, or from which has been removed in preparing or trimming the meat any pleura, peritoneum or lymphatic gland.

This recognition does not extend to boneless veal appearing to an authorised officer to be from calves less than three months old.

2. The said Certificate is recognised subject to the following conditions:

- (a) This recognition applies to meat and meat products imported from South West Africa/Namibia.
- (b) Where the Official Certificates are in the form of labels, the recognition will apply only if the labels are securely affixed to the meat or the meat product or the package containing the meat or the meat product, and if the labels have not in any circumstances or on any other occasion been used as Official Certificates.
- (c) Where the Official Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat or the meat product and the package containing the meat or the meat product.

The Notices published in the London Gazette dated 9th March 1962 and in the Belfast Gazette on 29th November 1968 will remain in force until 1st November 1980 from which date they will be revoked.
