NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor in exercise of the powers conferred on him by Section 23 of the Magistrates' Courts Act (Northern Ireland) 1964 and Section 7 of the Costs in Criminal Cases Act (Northern Ireland) 1968 on the advice of the Magistrates' Courts Rules Committee and after consultation with the Lord Chief Justice has made a Statutory Rule entitled the Magistrates' Courts (Costs in Criminal Cases) Rules (Northern Ireland) 1980. (SR 1980 No. 372.) These rules which come into operation on 1st December, 1980 provide for the maximum amounts which may be ordered by a Magistrates' Court in a criminal case to be paid by the defendant or, as the case may be, by the prosecutor for solicitors' or counsel's fees or for personal litigants' costs or in connection with the attendance of witnesses at the hearing. The rules replace the Magistrates' Courts (Costs in Criminal Cases) Rules (Northern Ireland) 1979, which are revoked. The new rules increase certain amounts payable in connection with the attendance of witnesses.

These rules which come into operation on 1st December, 1980 make provision, in relation to courts of summary jurisdiction, for the various matters which are to be prescribed under the Domestic Proceedings (Northern Ireland) Order 1980. Provision is further made about orders for the protection of such parties and children from domestic violence and about the enforcement, variation, revocation and cessation of orders to which the rules apply.
